## Actions Taken to Comply with the Settlement Agreement During Previous Month (August):

- Preparation of the Interim Investigation Deliverable as described in Section 6.2 of the RI/FS Work Plan continued in August 2019 and is due to the NYSDEC within 60-days of receiving the final analytical data package from the Phase 1 work. This activity also involves identification of data gaps in the Phase 1 of the RI and evaluation of additional investigations in Phase 2 of the RI.
- The third round of the periodic (quarterly) surface water sampling was completed on August 22, 2019. The final round is planned for October 2019.
- The status of the point-of-entry treatment (POET) system and non-POET location monitoring is provided in the attached tables.

# <u>Plans, Reports, and Other Deliverables Required by the Settlement Agreement Completed and Submitted in the Previous Month (August):</u>

# Results of Sampling, Tests and Any Other Data Received or Generated by or on behalf of Respondent During the Previous Month (August):

- Analytical results were received in August 2019 for filtered groundwater samples collected in May 2019. This data will be uploaded to the NYSDEC once validated by the third-party data validator.
- Analytical results received from Eurofins Lancaster Labs Environmental (ELLE) during the month for per- and
  polyfluoroalkyl substances (PFAS) for the POET systems and annual raw only properties were submitted to NYSDEC
  under separate cover on August 14, 15, 16, and 23, 2019. POET analytical results EDDs were submitted to NYSDEC on
  August 16, and 23, 2019, and successfully uploaded.

#### Activities Undertaken in Support of the Citizen Participation Plan (CPP) During Previous Month (August):

#### Actions, Plans and Data Scheduled for the Next Month (September):

- The borehole geophysical investigations described in Section 2.4.2 of the RI/FS Work Plan was performed on a new
  production well on September 5, 2019. Discrete interval groundwater sampling and hydraulic conductivity testing of this
  well is planned for September 2019.
- Analytical results are scheduled to be received from Eurofins for PFAS for the installed POET systems and raw water only locations with no POET systems.
- Alpha will continue sampling of the installed POET systems and raw water only locations with no POET systems.
- WEL-DUN will continue to provide installation and maintenance services of POET systems.
- Installation of POET system(s) not yet completed at locations included in Exhibit C of the Settlement Agreement will continue if accepted by the homeowners.

#### **Proposed or Approved Modifications (Work Scope and/or Schedule):**

As discussed with the NYSDEC on September 3, 2019, for the recently installed production well, a packer system
described in Section 6.5 of the Field Sampling Plan will be used to perform the depth-discrete groundwater profiling
and hydraulic conductivity testing.
