State Superfund Site Reclassification Notice Class 03 to Class 02

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on a map included with this notice, has been reclassified in the Registry as a Class 02 site that presents a significant threat to public health and/or the environment for the following reason(s):

- The site is on an active airport and is an air national guard base. On-site groundwater and surface water
 was found to be contaminated with per- and polyfluoroalkyl substances (PFAS), primarily perfluorooctane
 sulfonic acid (PFOS) and perfluorooctanoic acid (PFOA), at levels exceeding applicable standards,
 criteria, and guidance in the Site Inspection conducted by the National Guard Bureau.
- Additional investigation, which will be conducted by the Air National Guard is scheduled to commence in Federal Fiscal Year 2026 and is needed to define the nature and extent of contamination, to evaluate associated human exposure pathways, and to determine the appropriate actions that will need to be implemented to mitigate exposures to public health and the environment.


