Record of Decision

Site Name: NYSEG - Plattsburg Saranac St. MGP, Operable Unit 2 (OU-2) *

The New York State Department of Environmental Conservation (NYSDEC) announces that the printed Record of Decision (ROD) for the NYSEG - Plattsburg Saranac St. MGP site ("site") located at Saranac Street, City of Plattsburgh, Clinton County is available for public review (see "Where to View the ROD," below).

On Wednesday, March 14, 2018 NYSDEC held a public meeting presenting the Proposed Remedial Action Plan (PRAP) for the site. The comments received at this meeting and during the public comment period (February 28, 2018 through March 30, 2018), along with the administrative record, were considered in preparing the final ROD for the site. The ROD presents the remedy selected to address contamination related to the site and the rationale for the chosen remedy. A Responsiveness Summary addressing the public comments received is also included in the ROD.

Record of Decision

The following is a summary of the chosen remedy described in the ROD:

Summary of the Remedy for OU 02:

- Excavation and on-site processing of all visually coal tar-impacted sediment from the Saranac River stream bed.
- In areas where the bedrock is exposed during excavation and visual coal tar is observed, the bedrock surface will be cleaned prior to backfilling.
- On-site processing to separate finer materials for off-site disposal and coarser material for reuse after cleaning.
- Backfill of the sediment bed with clean material consisting of imported backfill and cleaned cobbles and boulders approved for reuse.
- Restoration in-kind of the Saranac River bed and any disturbed banks.

The estimated remedial cost is \$16,300,000.
