Term	Definition
Corrective Actions or Corrective Measures	Actions taken at a facility to clean up or address contaminants of concern and attain the cleanup objectives at a site.
Corrective Measures Study	A step in the RCRA corrective action process during which remediation alternatives are identified and evaluated.

#### I. INTRODUCTION AND OBJECTIVE




Figure 1. Project Location and Potential Environmental Justice Area(s)

This Public Participation Plan (PPP) has been prepared by Wyeth Pharmaceuticals, LLC (hereinafter referred to as "applicant") to fulfill and comply with the requirements of New York State Department of Environmental Conservation **Commissioner Policy 29, Environmental Justice and Permitting (CP-29)** for their proposed Resource Conservation and Recovery Act (RCRA) Corrective Action project that requires a Part 373 Permit renewal application and which has been determined by NYSDEC to potentially impact one or more potential environmental justice area (PEJA) (See Figure 1).

This PPP has been developed in accordance with the procedures established in CP-29 Section V.D and it aims to help ensure meaningful and effective public participation throughout the NYSDEC environmental permit review process. Public participation in the NYSDEC environmental permit review process means a program of activities that provides opportunities for stakeholders to be informed about and involved during the review of a proposed action.

The objective of this PPP is to outline and describe the program of activities that the applicant will implement to actively seek and enhance public participation during the application review process.

#### II. PROJECT DESCRIPTION AND PROPOSED ACTION

#### **Project Overview**

The applicant previously operated a pharmaceutical facility on the property consisting of research and development, manufacturing and warehousing. In 2017 all operations ceased at the Facility. The property was sold in 2018 and the applicant retained responsibility for certain corrective measures as required under the RCRA Corrective Action Program overseen by the New York State Department of Environmental Conservation (NYSDEC).

The applicant has prepared a Corrective Measures Study (CMS) Report for the subject Facility. The NYSDEC, in consultation with the New York State Department of Health (NYSDOH), is proposing final corrective measures for the aforementioned Facility.

The applicant has submitted an application to the NYSDEC to renew its Part 373 RCRA Corrective Action permit as required to implement the corrective measures.

#### Nature of Proposed Project/Action and Purpose

The goal of the corrective measures is to protect public health and the environment and achieve unrestricted use of the Facility to the extent feasible. These objectives were established through the corrective measures remedy selection process. The remedial action objectives for this Facility are summarized as follows:

#### Groundwater

- Prevent ingestion of groundwater impacted by Facility-related Contaminants of Concern (COC) above drinking water standards for potable water<sup>1</sup>.
- Prevent vapor intrusion from impacted groundwater to occupied buildings.
- Prevent the discharge of groundwater impacted by Facility-related COCs to surface water.

#### Soil

- Prevent ingestion/direct contact with impacted soils.
- Prevent inhalation exposure from potential volatilization of Facility-related COCs in soil.
- Remove/reduce impacts in soil that are potential source(s) of groundwater or surface water impacts.

#### Soil Vapor, Sub-Slab Vapor, and Indoor Air

 Mitigate potential current and future exposure to impacted indoor air resulting from soil vapor intrusion into buildings on-site and off-site through the use of engineering controls (e.g., sub-slab depressurization systems, vapor barriers).

<sup>1</sup> Although groundwater is classified as GA, the aquifer is non-productive and therefore is not used for human consumption. The only potentially potable water is surface water - Lake Champlain/Richelieu River. The best usage of Class GA waters is as a source of potable water supply. Class GA waters are fresh groundwaters as defined per 6 CRR-NY 701.15 Class GA fresh groundwaters.




Figure 2. [Site Plan]

#### **Potential Impacts**

The subject Facility ceased industrial operations in 2017 and is no longer active. Most of the buildings have been demolished and the current owner is moving forward with redeveloping the site into an industrial park. The proposed project will not disrupt redevelopment plans and will help to facilitate future use of the property. The planned corrective measures are intended to protect public health and the environment and achieve unrestricted use of the Facility to the extent feasible.

The applicant continues to investigate and remediate residual contamination on-site and is in the process of finalizing soil and groundwater investigations and remedy selection for the identified areas of concern.

In addition, vapor intrusion investigation activities including sub-slab soil vapor sampling, indoor air sampling, and outdoor air sampling were conducted at off-site properties in 2008, 2009, 2019, and 2020 in order to evaluate the potential for vapor intrusion into indoor air at several off-site locations. These investigations primarily focused on residential properties to the east and southeast of the Facility, though the 2019 to 2020 investigation also included properties to the north and south of the Facility.

Based on the results of these investigation activities, measures to address sub-slab soil vapor were initiated at several off-site properties consisting of the installation of soil vapor mitigation

systems in the form of Sub-slab Depressurization Systems similar to those installed to address radon. The applicant actively maintains these vapor mitigation systems beneath certain houses in the surrounding neighborhood while completing the on-site remediation. Operation of the off-site soil vapor mitigation systems will continue until such time as they are no longer required following consultation with NYSDOH and NYSDEC.

## III. STAKEHOLDER IDENTIFICATION & CONTACT LIST

A contact list consisting of the names, addresses, phone numbers, or email addresses of stakeholders to the proposed action is provided in Appendix A. The contact list includes individuals and organizations with a direct stake in the proposed action and people and individuals and organizations that have expressed interest in the proposed project or similar projects affecting the same neighborhood or community.

To develop a draft contact list, the applicant reached out to the current property owner and the Village of Rouses Point and consulted the following local resources Rouses Point website, Town of Champlain website, the Rouse Point Community Redevelopment Strategy and Implementation Plan, and the North Country Regional Economic Profile, to help identify stakeholders and develop an initial contact list.

The current contact list has been developed in consultation with NYSDEC and the Village of Rouses Point by identifying stakeholders from the following categories: local government and elected officials; business owners, residents, and occupants; local civic, community, environmental and religious organizations; local news media; administrator/operator of any school or day care that live, work and/or represent a neighborhood or community within 1) the mitigation area, 2) the one-quarter mile radius of the subject property, and 3) the portion of the Potential Environmental Justice Area within one-half mile of the subject property (see Figure 3).

The applicant will utilize this contact list to communicate and disseminate information about the proposed project/action and permit application review process to the affected community and stakeholders. At minimum, this includes distribution of the written information and outreach.

The contact list will be reviewed periodically and updated as appropriate throughout the permit application review process. The applicant will update the contact list with any new stakeholders identified during the execution of other PPP components. In addition, individuals and organizations will be added to the contact list upon request. Such requests should be submitted to the project liaison identified in Section IV. Other additions to the contact list may be made at the discretion of the applicant or, at the request of the NYSDEC project manager, in consultation with other NYSDEC staff, as appropriate.

Impacted residents and interested stakeholders can contact the project liaison listed above to provide input to the project team, discuss any issues or concerns and/or to ask questions or request information. The project liaison shall respond in a timely manner and in the manner appropriate to the question or information request received. The project liaison will be responsible for tracking and documenting public input, inquiries, questions, and information requests received, along with responses provided.

## V. PUBLIC OUTREACH ACTIVITIES

The applicant will utilize a range of engagement strategies and conduct various public outreach activities to facilitate participation, involvement, and direct communication with the affected community during the permit application review process. The applicant will implement the public outreach activities outlined below upon finalization and approval of this PPP by NYSDEC.

In compliance with the requirements of CP-29, the applicant will keep the public informed about the proposed action and the environmental permit review process. At minimum, the applicant will prepare, distribute and post written information and materials, including fact sheet, to encourage dialogue and solicit input from interested stakeholders during the permit application review process. In addition, to complement the minimum requirements, the applicant will post all written information and materials on the project website at <a href="https://www.RPupdate.com">www.RPupdate.com</a>. All public outreach materials and information will be prepared and presented in an easy-to-read, understandable format, using plain language free of legal terminology, and geared towards a non-technical audience.

The fact sheet will be made available and disseminated in English based upon input from the Village of Rouses Point and the following demographic information. According to the U.S. Census Bureau, 93.2% of the population speak only English at home. While 21.9% of Rouses Point residents have a reported ancestry of French, Census data further shows that of the 6.8% of the population that speak a language other than English at home 0.9% speak Spanish, 1.5% speak Asian languages and 4.4% speak Indo-European languages. The U.S. Environmental Protection Agency Environmental Justice Screening tool, EJScreen, reports a 0% Value of Limited English Speaking Households for the half-mile radius of the subject site. Based upon this information, the fact sheet will be prepared in English. In addition, the public can contact the project liaison regarding the availability of language assistance and to request that the notice and fact sheet are translated into another language for comprehension by non-English speaking or limited proficiency stakeholders.

#### **Fact Sheet Preparation and Distribution**

Factual information on the proposed project/action, including an overview, purpose statement, and potential impacts, is outlined in the reader-friendly fact sheet shown in Appendix C. In addition, the fact sheet outlines how interested stakeholders can: participate in the permit application review process; access the online document repository to review relevant application materials; and contact the project team to obtain additional information. The fact sheet has been prepared in English and will be translated into French by a certified translator, if requested.

Once the PPP has been approved by NYSDEC the fact sheet will be posted and available in the online document repository described in Section VI of this document. The applicant will distribute the fact sheet to provide stakeholders with relevant background on the proposed project/action and facilitate meaningful participation in the public comment process. The fact sheet will be distributed via email, mail and/or hand delivery (door-to-door).

The fact sheet(s) will also be posted within the vicinity of the project site and visible to the public. For example, they may be posted on some streetlight lampposts or bulletin boards located in the lobby of residential complex buildings or public facilities such as libraries, schools, or community centers within the project site.

#### **Distribution of Notice of Complete Application**

Once NYSDEC determines the application(s) for the proposed action/project is complete and provides the Notice of Complete Application (NOCA) to the applicant, the applicant will distribute the NOCA and draft permit, if applicable, to the meeting attendees and any identified interested parties, to provide notification regarding the start of the NYSDEC public comment period and to announce the deadline for submission of written comments to NYSDEC. If the NOCA is available at the time of the meeting, the applicant will distribute the NOCA at the public meeting. If the NOCA is not available at the time of the meeting, the applicant will provide

explicit instructions on how to access the online repository and inform the attendees that, once available, the NOCA will be posted to the online document repository and will be distributed to attendees via email or mail as soon as possible, but no later than the date that the NOCA is published by the applicant in the print edition of a paid local newspaper that is circulated at least weekly and available in the municipality in which the project is located.

#### **Additional Outreach and Materials**

The written information and materials, including the fact sheet, will be posted on the project website at <a href="https://www.RPupdate.com">www.RPupdate.com</a>.

The Fact Sheet will be mailed directly to property owners in the stakeholder contact list as described in Section III above, which includes the surrounding neighborhood, as well as all property owners who currently have active vapor mitigation systems in their homes or buildings A copy of the Fact Sheet will also be provided to the Village Administrator for posting at the Village Hall.

## VI. DOCUMENT REPOSITORY

An online document repository has been established for the community and interested stakeholders to access and review information about the project. The online repository available at RPupdate.com (<a href="https://rpupdate.com/document-repository/index.html">https://rpupdate.com/document-repository/index.html</a>) will provide information and documents relating to the project and permit application.

The repository will be updated throughout the application process with project-related information and written materials (i.e., application forms and supporting materials, draft permit, fact sheet, statement of basis (where applicable), the Notice of Complete Application provided by the NYSDEC, etc.).

Furthermore, the Village of Rouses Point will be provided with the link to the online repository and will post the link of the Village website (<a href="www.rousespointny.com">www.rousespointny.com</a>) and the Village Facebook page.

## VII. SUBMISSIONS

#### **Final Summary Report and Written Certification**

Upon completion of the enhanced public participation plan, the applicant will submit written certification to NYSDEC to certify that it has fully executed and complied with the approved PPP. The certification shall be signed by the applicant, or the applicant's agent, and submitted to NYSDEC prior to a final decision on the application.

As part of the certification, the applicant shall submit a final summary report documenting the implementation of this PPP. The report will summarize the activities that occurred in accordance with the PPP and will identify any substantive concerns raised by stakeholder, at any time throughout the permitting process and detail the applicant's response(s) to any such concerns or questions. The applicant will include, or append, any documentation that supports the final summary report, copy of newspaper notice or other proof of publication. In addition, the report will identify any changes or modifications to the proposed project that were made or considered by the applicant to address or reduce concerns surrounding the permit application.

The final summary report and written certification will become part of the application record and will be posted to the online document repository so that it is readily available to the public.

# **Wyeth Corrective Measures Fact Sheet**

- Project: Former Wyeth Pharmaceuticals Site Proposed Corrective Measures

#### What is the Proposed Project?

NYSDEC, in consultation with the New York State Department of Health (NYSDOH), is evaluating final corrective measures proposed by the Wyeth facility in Rouses, Point, NY. A Statement of Basis (SB) identifying the proposed corrective measures is being prepared for public comment. The SB contains the proposed corrective measures intended to attain the cleanup objectives identified for this facility for the protection of public health and the environment. The applicant has submitted an application to the NYSDEC to renew its Part 373 RCRA Corrective Action permit as required to implement the corrective measures.

The Proposed Corrective Measures include:

- In-situ Chemical Reduction (ISCR) to address impacted soils. ISCR is a method used in place to break down chemicals to less harmful components.
- Monitored Natural Attenuation (MNA) which involves periodic sampling to document that the natural breakdown of components is continuing and ensure that the chemicals are not migrating away, and
- Institutional Controls (IC) to address contamination in the groundwater resulting from historic
  operations at the facility. ICs are legal or administrative measures, such as the placement of
  restrictions on the property deed (environmental easements) that may be used to limit certain types
  of land use in the future.

In addition, sub-slab depressurization systems will continue to be used to mitigate soil vapors beneath on and off-site buildings as required. More information on the recommended corrective measures is included in the SB which can be found in the document repositories. The purpose of this fact sheet is to inform the public about the proposed project and to involve the community during the NYSDEC corrective measures decision-making process.

#### Why does Wyeth need to obtain a permit for and approval of the Corrective Measures?

The NYSDEC has determined that hazardous wastes and/or hazardous constituents were released into the environment at the facility located at 64 Maple Street in Rouses Point, NY. NYSDEC is proposing final corrective measures intended to attain the cleanup objectives identified for this facility for the protection of public health and the environment.

The SB identifies the proposed corrective measures, summarizes the other alternatives considered, explains the reasons for selecting the proposed remedy, and solicits public involvement in the selection of the final corrective measures. NYSDEC will select final corrective measure(s) only after the public comment period has ended and the information submitted during this time is reviewed and considered in the decision-making process.

In addition, the applicants have submitted an application to the NYSDEC to renew its Part 373 RCRA Corrective Action permit as required to implement the corrective measures.

#### How might the project affect the surrounding community?

The Proposed Corrective Measures include the use of In-situ Chemical Reduction (ISCR) to address impacted soils. This will require physical construction work on the subject property. At the completion of the on-site work, institutional controls will be put in place limiting future use of the property to commercial and industrial land uses. As proposed, groundwater will be monitored long-term to demonstrate the continued degradation, or decrease, of contaminants, through natural processes.

If further sampling identifies a need, the potential for volatile organic chemicals to migrate from the soil into the indoor air of future buildings constructed onsite will be mitigated using sub-slab depressurization systems. Existing off-site soil vapor mitigation systems will continue until the Department evaluates the systems are no longer needed.

The SB provides an opportunity for the public to be informed of and to participate in the selection of the final corrective measures for the facility. Public input on all potential remedial alternatives, and on the information that supports the alternatives, is an important contribution to the corrective measure selection process. The Department may modify the proposed remedy or select another remedy based on new information and/or public comments.

#### **Environmental**

The ~78.6-acre former manufacturing facility was originally built in 1880 and first occupied by Canadian-based Ayerst, McKenna and Harrison in 1934. In 1943, Ayerst became a part of American Home Products (AHP). In 1987, AHP formed Wyeth-Ayerst Laboratories. The company later became known as Wyeth Pharmaceuticals, Inc. (Wyeth). In 2009, Pfizer acquired Wyeth, and pharmaceutical manufacturing continued at the Rouses Point site. Pfizer discontinued manufacturing operations at the end of 2017.

Hazardous waste management activities at the Rouses Point site were regulated by the U.S. Environmental Protection Agency (EPA) and NYSDEC under a RCRA Corrective Action Permit most recently modified in October 2014.

#### **Environmental Conditions**

The former manufacturing site historically consisted of two operations, the Main Plant and the Chemical Development Plant. In 2006, as part of its Hazardous Waste Management Permit requirements, Wyeth notified the NYSDEC of 10 Areas-of-Concern (AOC) and 26 Solid Waste Management Units (SWMUs) on the site. A series of soil and groundwater investigations identified a limited number of compounds, including volatile and semi-volatile organic compounds, metals and polychlorinated biphenyls (PCBs) detected in soil or groundwater at the site.

#### Site Soils and Solid Waste Management Units

Pfizer has achieved No Further Action (NFA) status on four AOC and one SWMU at the Main Plant, and NFA approval from NYSDEC is pending on thirteen additional SWMUs and one AOC. Investigation of the remaining SWMU on the Main Plant is ongoing.

At the former Chemical Development Pilot Plant, NFA status was approved by NYSDEC for two AOC, as well as one SMWU and a portion of two other SWMUs. Furthermore, based upon the RCRA facility assessment performed by Pfizer, No Further Action has been recommended for all remaining areas and units at the former Chemical Development Plant.

Pfizer has submitted a Draft Corrective Measures Study Report to NYSDEC which proposes final corrective measure alternatives at the site in the event future investigation activities indicate that remediation activities are warranted. The proposed remedial alternatives for soil include excavation and Monitored Natural Attenuation (MNA). NYSDEC is currently reviewing the draft report.
