State Superfund Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on a map on the reverse side of this page, has been added to the Registry as a Class 02 site that presents a significant threat to public health and/or the environment for the following reason(s):

- Perfluorooctanoic acid (PFOA) and perfluorooctanesulfonic acid (PFOS) have been detected in compost leachate, soils, groundwater, and surface water at levels that exceed applicable standards, criteria, and guidance. Contaminated groundwater is likely to be migrating off-site towards Whipple Brook (a tributary of the Hoosic River). Private drinking water wells were and continue to be sampled and analyzed for PFOA and PFOS in the surrounding area as part of the Washington County PFOA Investigation (under the DEC Spills Program; #1601507). Private wells that have sampling results above the NYS Maximum Contaminant Level of 10 parts per trillion for PFOA or PFOS have Point of Entry Treatment systems installed and maintained. Additional investigation is needed to define the nature and extent of site-related contamination, to evaluate associated human exposure pathways, and to determine appropriate actions to prevent and mitigate potential exposures.

DEC will keep you informed throughout the investigation and cleanup of the site.
