The New York State Department of Environmental Conservation (NYSDEC) announces that the printed Record of Decision (ROD) for the Union Fork & Hoe site ("site") located at 253 East Main Street, Town of Frankfort, Herkimer County is available for public review (see "Where to View the ROD," below).

On Tuesday, February 27, 2018 NYSDEC held a public meeting presenting the Proposed Remedial Action Plan (PRAP) for the site. The comments received at this meeting and during the public comment period (February 7, 2018 through March 9, 2018), along with the administrative record, were considered in preparing the final ROD for the site. The ROD presents the remedy selected to address contamination related to the site and the rationale for the chosen remedy. A *Responsiveness Summary* addressing the public comments received is also included in the ROD.

### **Record of Decision**

The following is a summary of the chosen remedy described in the ROD:

- Installation of a site cover to allow for commercial use of the site.
- Contaminated soils in the top one foot will be excavated for off-site disposal or consolidated on-site below a soil cover.
- Soil which exceeds the hazardous waste threshold for metals will be treated prior to off-site disposal.
- An environmental easement will be placed on the site which will allow for commercial use of the site and restrict the use of groundwater at the site.
- Development and implementation of a Site Management Plan which will include site cover maintenance and long-term groundwater monitoring.

The estimated remedial cost is \$1,336,000.
