National Grid to begin Remedial Construction Activities at the Rome (Kingsley Ave.) Property Site No. 6-33-043

National Grid will begin remedial construction activities at the historical manufactured gas plant (MGP) site formerly located on Kingsley Avenue in Rome, New York. The former MGP site was owned and operated by a predecessor company to Niagara Mohawk Power Corporation. Pursuant to an agreement with the New York State Department of Environmental Conservation (DEC), National Grid has completed an extensive investigation of the impacts to soil and groundwater associated with the former MGP operations. The results of the investigation efforts were presented in a Remedial Investigation (RI) Report (Parson Engineering Science, Inc, March 1999) and are on file at the Jervis Public Library, 613 N. Washington St, Rome, NY.

Background Information

While owned by the Rome Gas, Electric Light and Power Company (1917 – 1923) and subsequently the Northern New York Utilities (1923 - 1930) this plant heated coal and produced a "manufactured" gas which was utilized for lighting, heating and cooking by Rome homes and businesses. By the early 1930s, the City was supplied with gas from a regional MGP facility located in Utica, NY. Local gas production at Kingsley Ave plant ceased about this time, operating perhaps only on a seasonal (winter) basis. The facility and accompanying property were transferred to Niagara Mohawk in 1950 as part of its incorporation from many smaller companies, including the Northern New York Utilities.

In 1992, Niagara Mohawk entered into a *Order on Consent* with the New York State Department of Environmental Conservation (NYSDEC) to evaluate and, where necessary, remediate MGP by-products that may remain at 24 former MGPs sites located throughout the New York State. The Kingsley Ave. property is one of those former MGP sites. National Grid acquired Niagara Mohawk in 2002 and assumed responsibility for the investigation of the former MGP.

Environmental Remedial Activities and Scheduled

Implementation of remedial activities will involve a three-year phased construction schedule with phase one to start in May 2007, to accommodate planned upgrades to the overhead distribution and transmission lines as well as the existing electrical substation currently on the property. Phase one will include site preparation activities, some demolition of existing site structures and shallow soil removal activities.

Major elements of the selected on-site remedy, as approved by the NYSDEC, will include:

- Excavation of approximately 22,000 cubic yards of impacted soils and transport offsite for thermal treatment and disposal.
- Demolition and removal of several underground MGP structures including tar wells, distribution and relief holder foundations.
- Construction of a 45-feet deep steel, sheetpile barrier wall to facilitate the containment and collection of impacted groundwater.
- Construction of a small groundwater treatment plant. Treated groundwater will be discharged to the Mohawk River.
- Removal of approximately 800 cubic yards of impacted sediments from a backwater area located just above the spillway on the Mohawk River.
- Construction of a soil cover over approximately 14 acres in the northern portion of the site to prevent exposure to impacted soils that may remain.
- Implementation of a long-term operation and maintenance plan to monitor groundwater quality and ensure that engineered controls (e.g. groundwater treatment system, soil cap, etc.) continue to function as designed, and
- Implementation of "Institutional Controls" to include: prohibition of land development for residential use, compliance with approved soil management plans for future activities, notification to the NYSDEC prior to any future activity that could jeopardize the integrity of the remedy.


Additional remedial measures to address off-site contamination are under consideration.

In order to reduce exposures to site-related contaminants, a site specific Health and Safety and Community Air Monitoring Plans (HASP and CAMP) will continue to be implemented whenever contaminated media is exposed. The HASP was designed to protect personnel involved in the remediation of the site. The CAMP was specifically designed to protect off-site receptors such as community residences, businesses and on-site workers not involved with the site remediation, from inhaling and ingesting site-related contamination. Both the HASP and CAMP contain stringent on-site and off-site air monitoring programs designed to protect workers and the community from site-related contamination.

Work at the site will be conducted in a safe and controlled manner according to the Health and Safety Plan prepared specifically for this project. If other actions are needed in the future, then all work will be monitored to protect workers and local residents.
