State Superfund Site Delist Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). DEC has determined that this site (see map on reverse side) no longer presents a threat to public health or the environment and is proposing to delist the site from the Registry for the following reason(s):

Remedial actions including the removal of polychlorinated biphenyl (PCB) contaminated on-site and off-site soil and sediment as well as removal of construction and demolition debris have been satisfactorily completed in accordance with the March 2001 Record of Decision. The disturbed areas of the on-site unnamed tributary and off-site Sauquoit Creek were restored with soils meeting unrestricted use standards. Since all remediated areas met unrestricted or residential use soil cleanup objectives, institutional controls are not required as there are no remaining human exposures to soil or sediment contamination.

Public comments are being received before the decision to remove the site from the Registry is finalized. The public comment period will end November 29, 2019. 
