SCOPE OF WORK (Provide brief detailed description):

This work authorization is to implement a mechanical soil turning program in accordance with the June 29, 2007 ROD. The following tasks will be part of this work authorization:

1. The consultant and contractor will mobilize to the site by August 24, 2011. Excavators will be used to remove the remaining contaminated soils found in and below the on-site soil piles.
2. Clean soil from either on-site or from an approved off-site supplier will be used to bring the bottom of the excavation above the water table and to stabilize the side slopes.
3. Larger debris will be removed for off disposal at an approved solid waste disposal facility.
4. Soils will be mechanically turned to treat petroleum related compounds. Soils will be treated until there is no evidence of visual or olfactory impacts.
5. Confirmation soil testing will be conduct for VOCs and SVOCs at a rate of 1 per 1000 cubic yards. Samples will be obtained and prepared by the Consultant for shipment to Upstate Laboratories.
6. Treated soils will be placed in the excavation area or graded on-site. Adequate erosion control is required.
7. The consultant will monitor the progress of the soil turning and document field conditions utilizing visual, olfactory and photoionization detector. Material estimates will also be required to document the volume of soils turned.
8. Within 60 days of completion of the project, a summary report will be provided to the Department.

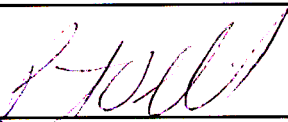
ESTIMATED BUDGET: \$ 300,000.00

The DER project manager must confirm that approval in writing in an amended Standby Contractor Authorization Form signed by the DER project manager and Rep within two business days.

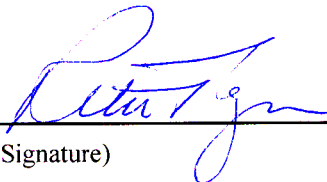
