State Superfund Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on a map on the reverse side of this page, has been added to the Registry as a Class 2 site that presents a significant threat to public health and/or the environment for the following reason(s):

Perfluorooctanoic acid (PFOA) and perfluorooctanesulfonic acid (PFOS) have been detected in soil, groundwater, and surface water at levels that exceed applicable standards, criteria, and guidance. Contaminated groundwater is likely migrating offsite toward Stony Creek. Several public water supplies and private wells were sampled and analyzed for PFOA and PFOS, but none had results above the NYS Maximum Contaminant Levels of 10 parts per trillion in drinking water. PFOS has also been detected in wetland sediments.

DEC will keep you informed throughout the investigation and cleanup of the site.

Health Assessment

Access to a portion of the site is restricted by a fence and people who enter the site could come into contact with site-related soil contamination by walking on the site, digging, or otherwise disturbing the soil. People are not drinking the contaminated groundwater because the area is partially served by a public water supply that is not affected by this contamination, and environmental sampling indicates that people are not drinking the site-related contaminated groundwater. People may come into contact with site-related contaminants in the surface water and wetland sediments.


