AMENDMENT TO ENVIRONMENTAL EASEMENT

This Amendment to Environmental Easement is made as of this <u>st</u> day of <u>kcember</u> 2023 by and between The People of the State of New York, acting through their Commissioner of the Department of Environmental Conservation (the "Department") with its headquarters located at 625 Broadway, Albany, New York 12233, and Connor J. Burt ("Grantor") with a mailing address of 2367 State Highway 812, De Kalb Junction, New York 13630.

RECITALS

- 1. Grantor is the owner of certain land located at the address of Newcomb Road in the Town of Lisbon, County of St. Lawrence, and State of New York, known and designated on the tax map of the County Clerk of St. Lawrence as parcel numbers Section 49.004, Block 1, Lots 29 and 41, being the same as that property conveyed to Grantor by deed dated December 2, 2021 and recorded in the St. Lawrence County Clerk's Office as Instrument Nos. 2022-00002967 (the "Property").
- St. Lawrence County, predecessor of Grantor, executed that certain Environmental Easement ("Easement Agreement") dated as of September 7, 2016 and recorded in the St. Lawrence County Clerk's Office on September 8, 2016 as Instrument No. 2016-00011339. Capitalized terms used herein without definition have the meanings ascribed to them in the Easement Agreement.
- 3. Pursuant to Section 1, 2, 3, 4, and 5 of the Easement Agreement, St. Lawrence County conveyed to the Department real property rights that run with the land to facilitate the remediation of past environmental contamination at the Property and imposed use restrictions and covenants to protect human health and the environment by reducing the risk of exposure to contaminants.
- 4. Pursuant to Section 17(h) of the Easement Agreement, St. Lawrence County and the Department agreed that the United States, through the United States Environmental Protection Agency ("EPA"), shall be, on behalf of the public, a third-party beneficiary of the benefits, rights, and obligations conveyed to the Department by the Easement Agreement.
- 5. Pursuant to Section 3 of the Easement Agreement, the Property may only be used consistent with restrictions set out in that section of the Easement Agreement. The Department and EPA have determined that the restriction set forth in Section 3(ii) of the Easement Agreement, a Property-wide prohibition on groundwater extraction, is no longer necessary to protect human health and the environment.
- 6. This Amendment to Environmental Easement is filed solely in order to revise the restriction set forth in Section 3(ii) of the Easement Agreement.
- 7. Pursuant to Section 4 of the Easement Agreement, the Department agrees to amend the Easement Agreement in the manner prescribed by Article 9 of the Real Property Law.


