- Respondent Downside Risk, Inc. is a domestic business corporation organized 1. and existing under the laws of the State of New York, who executed and became the Respondent under Order on Consent No. R7-20220610-32.
- Respondent Vestal Self Storage LLC is a domestic business corporation 2... organized and existing under the laws of the State of New York.
- The New York State Department of Environmental Conservation ("Department") is responsible for inactive hazardous waste disposal site remedial programs pursuant to Article 27, Title 13 of the Environmental Conservation Law ("ECL") and Part 375 of Title 6 of the Official Compilation of Codes, Rules and Regulations ("6 NYCRR") and may issue orders consistent with the authority granted to the Commissioner by such statute.
- 4: The Department is responsible for carrying out the policy of the State of New York to conserve, improve and protect its natural resources and environment and control water, land, and air pollution consistent with the authority granted to the Department and the Commissioner by Article 1, Title 3 of the ECL.
- Respondent Downside Risk, Inc. and the Department entered into an Order on Consent and Administrative Settlement No. R7-20220610-32 ("Consent Order") on September 2, 2022 regarding Superfund Site No. 704007 located at 3201 Steward Road, Vestal, NY 13850, Tax Map/Parcel No.: 158.11-1-15.
- Respondents provided an incorrect Respondent corporate name for a Vestal Self Storage LLC in the Consent Order.
- Respondent Vestal Self Storage LLC wishes to modify the Consent Order to 7. correct and add the correct corporate entity Vestal Self Storage LLC as the additional respondent.
- Respondents consent to the issuance of this Order without (i) an admission or finding of liability, fault, wrongdoing, or violation of any law, regulation, permit, order,

requirement, or standard of care of any kind whatsoever; (ii) an acknowledgment that there has been a release or threatened release of hazardous waste at or from the Site; and/or (iii) an acknowledgment that a release or threatened release of hazardous waste at or from the Site constitutes a significant threat to the public health or environment.

9. Solely with regard to the matters set forth below, Respondent hereby waive any right to a hearing as may be provided by law, consent to the issuance and entry of this Order, and agree to be bound by its terms. Respondents consent to and agree not to contest the authority or jurisdiction of the Department to issue or enforce this Order, and agree not to contest the validity of this Order or its terms or the validity of data submitted to the Department by Respondents pursuant to this Order.

NOW, THEREFORE, IN CONSIDERATION OF AND IN EXHANGE FOR THE MUTUAL COVENANTS AND PROMISES, THE PARTIES AGREE TO THE FOLLOWING:

## WHEREAS,

- The Order is hereby amended to add Vestal Self Storage LLC as a Respondent to the Consent Order and this Amendment.
- Respondents and its Successors and Assigns shall be bound by the Consent Order and its Amendments.
- III. Nothing contained in this Amendment changes or modifies the remaining obligations under the Order.
- IV. This Amendment shall control to the extent of a conflict between the provisions hereof and those of the Order. Except as provided in the preceding sentences or elsewhere in this Amended Order, the Consent Order and the documents related thereto, shall continue in full force and effect. Any amendment or other modification of this Amendment must be in writing.
- V. The effective date of this Amended Order shall be the date on which it is signed by the Commissioner or the Commissioner's designee.
