The New York State Department of Environmental Conservation (Department) is in receipt of the October 28, 2008 letter from Mr. Scott Fennell, P.E., regarding the proposed sale of a portion of the former Borden Inc., Facility. On behalf of Columbus Real Estate, LLC, Mr. Fennell provided an updated survey and legal description of the approximately 111 acre parcel to be conveyed, and the professional engineer certification that the Department had requested in an August 26, 2008 letter. The certification indicates that there are no outstanding remedial obligations associated with the parcel. Therefore, in accordance with Paragraph XXVII, by this letter the Department is amending the Article 27, Title 13, Order-On-Consent, Index #A7-0121-87-09 to specifically exclude the parcel (see enclosed figure and legal description) from the Order.

Even though, based on the current information and the Engineer's certification, we don't anticipate any problem with the parcel under consideration, the new owner should be aware that since the property to be conveyed was part of a RCRA interim status facility, the Department retains future RCRA corrective action enforcement authority per Article 71 Title 27 of the State's Environmental Conservation Law. Under this provision, the Department can require corrective action as necessary to protect human health and the environment.


