The calibration verifications that were associated with these samples had several of the early eluting analytes fall out of the 30% acceptable deviation range stated in this method. It was determined that a bad standard had been used, but since the initial calibration that these samples were quantitated against was valid, any reported values for these early analytes should be considered acceptable. None of these compounds were found in the samples run under these calibration verifications.

All other QA/QC associated with this sample delivery group were within acceptable method criteria.
