State Superfund Site Delist Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). DEC has determined that this site ([see map on reverse side](#)) no longer presents a threat to public health or the environment and is proposing to delist the site from the Registry for the following reasons:

- Impacted soil has been excavated and removed from the site.
- Site-related contaminants pentachlorophenol (PCP), polychlorinated dibenzo-p-dioxins (dioxins), and polychlorinated dibenzofurans (furans) have not been detected at concentrations exceeding NYSDEC Class GA Groundwater Quality Standards in any site monitoring wells since 2011.
- Remedial actions are complete and remaining soil meets cleanup criteria for commercial use of the site.

Public comments are being received before the decision to remove the site from the Registry is finalized. The public comment period will end March 26, 2021. A summary of comments will be assembled and made available for viewing at our Albany Office.

If we do not receive any new or additional information during this public comment period that changes our delist proposal, we will delist the site on or after April 25, 2021.

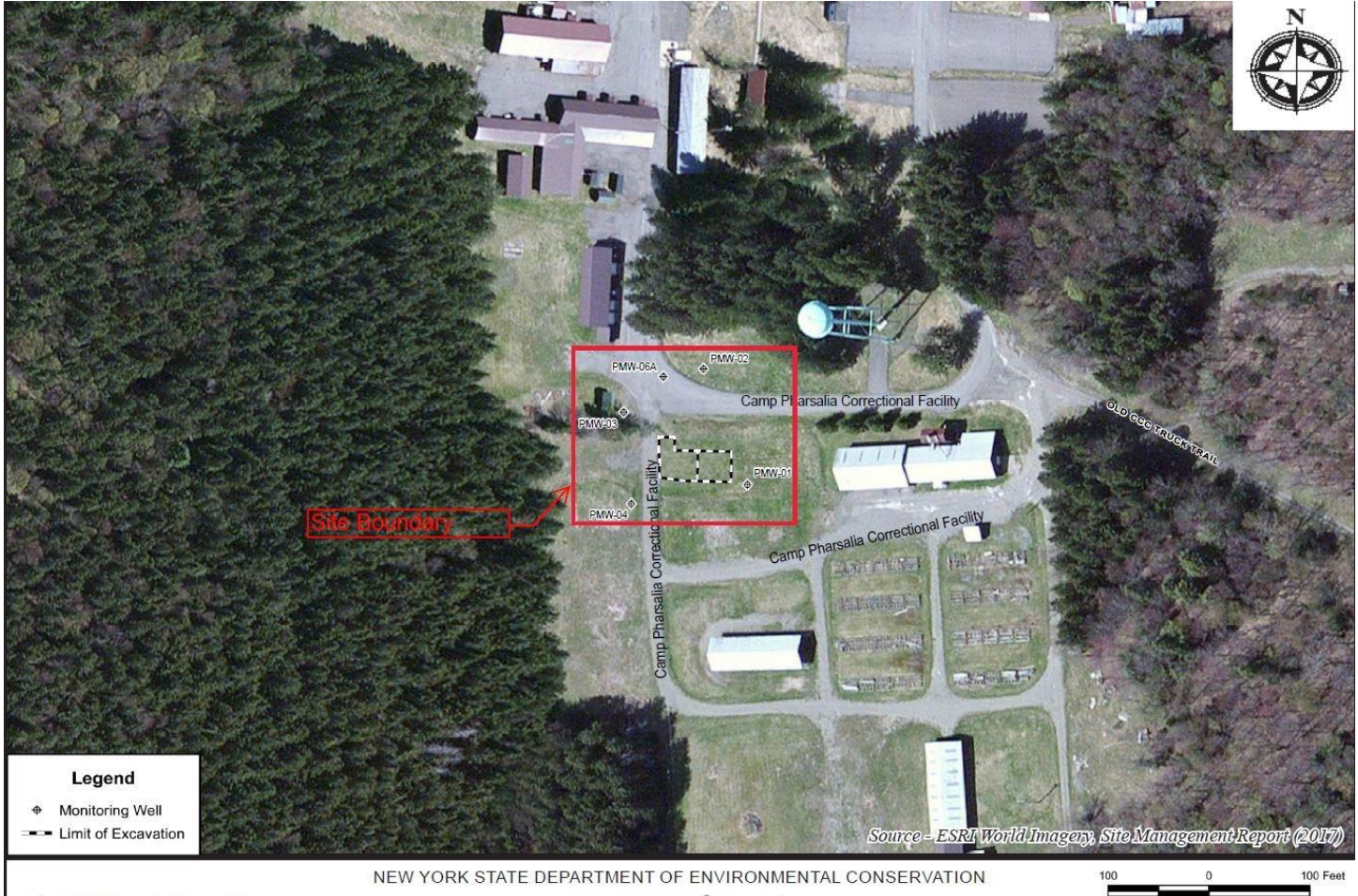
