Cleanup Action to Begin at Cortland Homer Former MGP Site

Action is about to begin that will address the contamination related to New York State Electric & Gas Company (NYSEG) - Cortland Homer Former Manufactured Gas Plant (MGP) ("site") located at Route 11 (South Main Street), Village of Homer, Cortland County under New York State's State Superfund Program. Please see the map for the site location.

The site is listed as a Class "2" site in the State Registry of Inactive Hazardous Waste Sites (list of State Superfund sites). A Class 2 site represents a significant threat to public health or the environment; action is required.

State Superfund Program: New York's State Superfund Program (SSF) identifies and characterizes suspected inactive hazardous waste disposal sites. Sites that pose a significant threat to public health and/or the environment go through a process of investigation, evaluation, cleanup and monitoring.

NYSDEC attempts to identify parties responsible for site contamination and require cleanup before committing State funds.

Documents related to the cleanup of this site can be found at the location(s) identified below under "Where to Find Information." The cleanup activities will be performed by NYSEG with oversight provided by New York State Department of Environmental Conservation (NYSDEC).

Highlights of the Upcoming Cleanup Activities

The approved remedy entails excavation of former MGP structures and debris; removal of soil; performing solidification of contaminated soils; and containing contaminated soils under Route 11. Soil solidification is a process that mixes an additive into the soil particles in place resulting in a solidified mass which reduces or eliminates mobility of contamination and reduces or eliminates the solidified mass as a source of groundwater contamination.

Air monitoring will ensure that local residents are not exposed to dust and vapors from the excavation above New York State Department of Health established guidelines. These precautions will also minimize the potential for odors from the excavation. In addition Route 11 will be temporarily rerouted during the installation of a sheet pile wall to contain contaminated soils under the road.

Next Steps

After completion of all the cleanup activities, NYSEG will prepare a Construction Completion Report. The Construction Completion Report will describe the cleanup activities completed and certify that cleanup requirements have been achieved or will be achieved.

The NYSDEC will keep the public informed throughout the cleanup of the site.

Background

In 1858, the NYSEG Cortland- Homer Manufactured Gas Plant (MGP) was constructed and began supplying manufactured gas to the Village of Homer under the name, "Homer and Cortland Gas Light Company". Manufactured gas was produced at this site using the coal gasification and carburetted water gas processes. Coal gas was produced on site until 1921, and then carbureted water gas was produced from 1921 to 1932. The gas holder was used until early 1935 for storing natural gas.

In the 1940s, NYSEG partially decommissioned the plant. In 1944 the Brockway Motor Company purchased the subject property and razed the remaining structures. The building that presently stands on the site is presumed to have been built by Brockway Motors and modified by subsequent owners.

Operable Units: The site was divided into two operable units. An operable unit represents a portion of the site that for technical or administrative reasons can be addressed separately to eliminate or mitigate a release, threat of release or exposure pathway resulting from the site contamination. Operable Unit (OU) No. 1 consists of the former manufactured gas plant (MGP) and adjacent off-site contaminated soils under NYS Route 11. OU 2 consists of the parcel of land between the river and NYS Route 11 and includes contaminated sediments in the West Branch of the Tioughnioga River.


