Inactive Hazardous Waste Disposal Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (Department) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (the "Registry"). The site identified above, and located on a map on the reverse side of this page, was recently reclassified on the Registry as a Class 4 site as it no longer presents a significant threat to public health and/or the environment for the following reason(s):

Drums and a minor amount of impacted soil were removed as an interim remedial measure along the eastern border of the landfill. Scrap metal was removed for recycling, and there was consolidation and placement of non-hazardous municipal waste beneath the final landfill cover consisting of two feet of clean soil. An environmental easement has been filed that prohibits future use of the site for any purpose other than its current use as a closed, capped landfill. The easement also restricts the use of groundwater without necessary water quality treatment and requires compliance with the approved site management plan. The site management plan provides details on the maintenance and repair of the landfill cover and the continued monitoring of the groundwater surrounding the site. The remedial party or site owner is required to submit a periodic certification that the institutional and engineering controls are in place and remain effective.

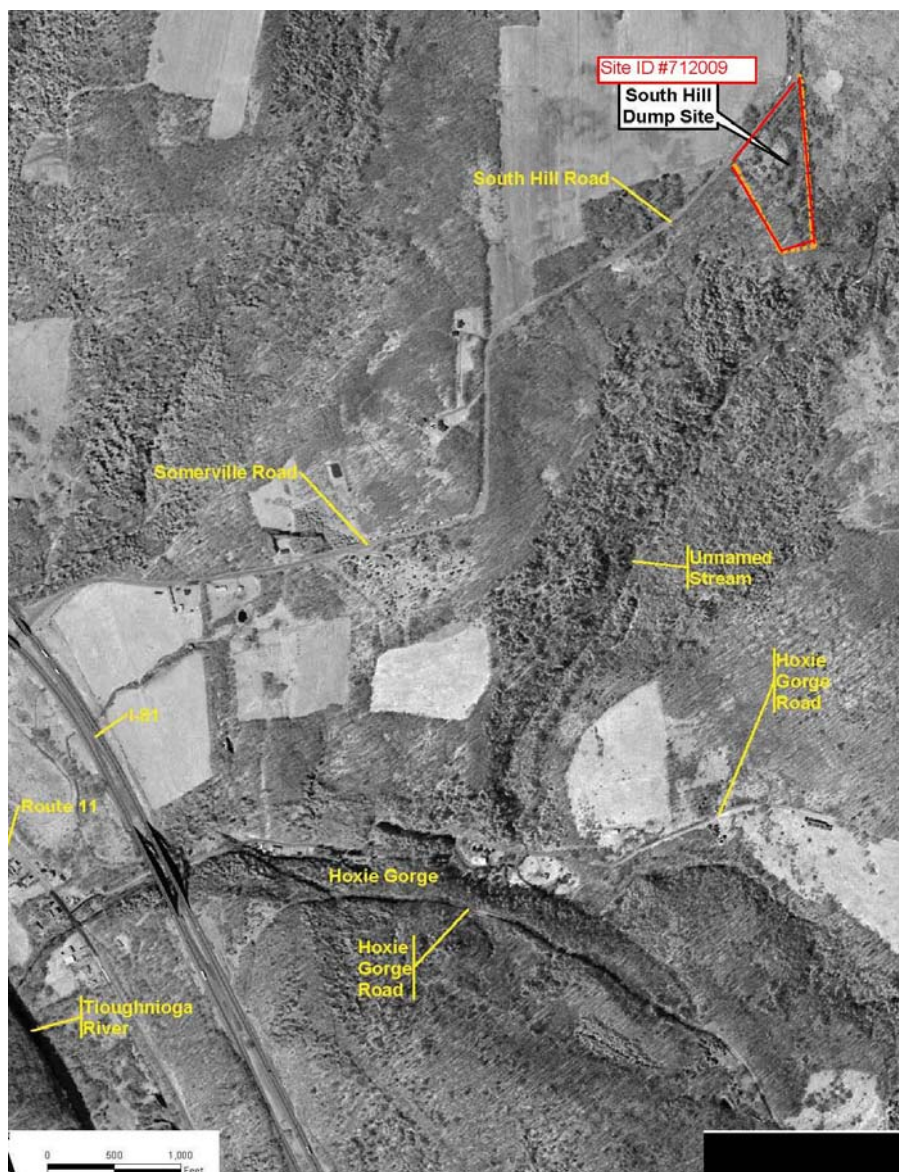
