- Completed HP-42 to 8 feet bgs. (Clay at about 7.5 bgs). Collected water sample.
- ADT developing monitoring wells completed earlier in the week.
- Completed DEC-1; located in front of #616 Court St, where impacts found down to 14 feet bgs. Had clean fill from 12-12.5 feet bgs. Gray silty clay 12.5-13.5 feet bgs. Gray fine to medium sand, gravel 13.5 to 19.5 feet bgs. Peat layer at 19.5-20 feet bgs. Fine sand, silt at 20-24 feet bgs. Silty clay, trace sand 24-28 feet bgs. End of boring.
- Completed DEC-2; located on north side of former brick structure. Tar, sheen, odor from 12-20 feet bgs. No impacts from 20-24 feet bgs. End of boring.
- Completed DEC-3; located southeast of former brick schedule. Slight staining, little odor at 4 feet bgs. No impacts seen from 4-20 feet bgs. End of boring.
- Attended scoping meeting for next phase of duct removal. Preliminary schedule stated by NYSEG is that mobilization will be on 4/19. Excavation will start on 4/22, at corner of Washington and Court. NYSEG gas will begin along north side of Court between Meadow and Washington on 4/5. City water department will begin installing new water line on 4/26. Restoration activities along first block hinges on rest of schedule, but most likely will not start until June.
