Description of work performed by contr. this report period:

• Contractor excavated material from middle and south side of court street. Material removed to a depth of 10 feet, including old sewer line. All visible contamination removed. Backfilled with clean material, installed new sewer line and tied in to residences. Approximately 100 tons contaminated materials excavated. Rainfall from previous night caused excessive groundwater inflow into trench, exceeding the rate at which water could be pumped out. Contractor had 5 trailers on order for waste hauling, but only 3 were used, with the remaining trucks sent back empty.
