### A. WORK PERFORMED – OCTOBER 2017

The ground water extraction and treatment system (GWETS) continues to operate 24 hours a day and is currently pumping and treating approximately 300 gallons per minute.

JCP's consultant Geosyntec began reviewing the results from the annual groundwater monitoring and sampling event that was conducted at the site during the week of September 18-22, 2017.

Monitoring wells OP-17 and BP-8 were resurveyed by Welch & O'Donoghuc Land Surveyors, P.C.

Prepare and submit the Annual Operation, Monitoring and Maintenance Report to the USEPA.
