### State Superfund Site Reclassification Notice Class 2 to Class 4

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on the attached map, has been reclassified on the Registry as a Class 4 site as it no longer presents a significant threat to public health and/or the environment for the following reason(s):

- Remedial activities at the site included the installation of a cap consisting of a soil cover with grass and trees to prevent erosion, along with the planting of selected vegetation (poplar and willow trees), which is designed to intercept off-site groundwater contaminated with volatile organic compounds and evaporate the contaminants into the atmosphere through the leaves of the trees.
- Human exposures to remaining contamination at the site were addressed through the implementation of a deed restriction and Site Management Plan (SMP). The deed restriction limits the property to commercial or industrial uses, prohibits the use of groundwater without prior approval, and requires compliance with the SMP. The SMP requires implementation of the institutional and engineering control plan, including implementation of an excavation work plan for future soil disturbances and periodic review reports every three years. Compliance with the approved SMP, and certification by the property owner to DEC, will ensure the institutional and engineering controls remain effective.
- Remedial actions have been satisfactorily completed in accordance with the 2001 Record of Decision (ROD) and measures are in place to prevent human exposures to contamination remaining at the site.
