

Dear Mr. Gallagher:

This letter is in response to your request of July 19, 1999, regarding your proposal to realign the main road on the KPX property. The following concerns must be addressed before and during the proposed work activities.

1. All activities need to proceed in accordance with applicable portions of Kodak's RCRA Corrective Action Program including the RCRA Facility Investigation (RFI) Health and Safety Plan dated November 1996 and the Excavation Master Plan II dated February 1996 (including the soil excavation permit process)
2. A Solid Waste Management Unit (SWMU) designated as SWMU X-046 is located in the vicinity of the proposed roadway. The SWMU is a former gasoline storage area and requires a future Sampling Visit (SV). Based on previous discussions between the Department and Kodak, a work plan has already been developed which addresses this SV. The work plan needs to be submitted to the Department for review and approval prior to the construction work. The SV investigation activities need to be completed prior to any construction that would interfere with the investigation. Additionally, the investigation results need to be submitted for Department review before the construction project is completed. Both the work plan and the investigation results can be submitted to Mark Domagala (NYSDEC Region 8, 6274 East Avon-Lima Road, Avon, New York 14414). If contamination is identified at levels that indicate potential impact to groundwater, remediation will be discussed with Mr. Domagala.

3. Several monitoring wells exist in the proposed construction area; however, the site plan submitted by Kodak does not show the location of these wells in proximity to the roadway. These monitoring wells must remain in the current locations and be protected during construction activities. The wells need to be adequately marked prior to construction activities to avoid potential damage during construction. Any wells that are damaged during construction will need to be repaired or replaced. Any damaged well that requires replacement needs to be decommissioned in accordance with the Department guidance entitled "Groundwater Monitoring Well Decommissioning Procedures" dated October 1996. The following monitoring wells are known to be located in the vicinity of the proposed construction activities: SB203W, GB203W, SB203S, GB207E, SB209NW, GB216W, and GB216E.

Copies of your letter will be distributed to all appropriate program areas within this Department.

Thank you for your cooperation in helping us to maintain accurate files on this site.


**Subject: 6 NYCRR Part 375 Notification of Substantial Change of Use at
Kodak Park**

6NYCRR Parts 375-1.2(f) and 375-1.6 require that the site owner of a registered inactive hazardous waste disposal site submit a 60 day notification prior to the start of a physical alteration, construction, or other substantial change of use. Pursuant to this requirement, Eastman Kodak Company hereby submits notification of plans to realign the main roadway in Kodak Park "X" (KPX) (Site Number 8-28-092). The realignment will consist of constructing a new roadway approximately 200 feet south of the present location. This new roadway will extend from the Mt. Read Boulevard bridge east for approximately 1500 feet, through the former Buildings 203 & 209 footprints, where it will transition back into the existing road.

The realignment of the roadway will eliminate the sharp "S" curve at the south end of Building 205. The construction activities for the roadway are anticipated to commence on September 20, 1999. Prior to that date certain activities, such as staking and grade preparation, may be initiated at this location.
