Remedial Action Work Summary

Work Activities Performed Onsite:

- Utility markout
- Preclearing of proposed injection points
- Community Air Monitoring Program

Roux was onsite to coordinate subcontractors and implement the community air monitoring program (CAMP). TREC Environmental, Inc. (TREC) and Lu Engineers used ground penetrating radar (GPR) to locate the subsurface utilities in the proposed injection locations and identified utilities were marked out with spray paint:

- Between Buildings 1 & 2 (MW-16s),
- North of Building 1 along the Erie Canal (MW-2s/m/d), and
- East of Building 3 (MW-35m).

TREC attempted to pre-clearing the proposed injection points proposed between Buildings 1 & 2 (MW-16s) and north of Building 1 along the Erie Canal (MW-2s/m/d). All attempted locations experienced refusal at 2.5' below grade or shallower. Obstructions such as large pieces of concrete, brick, and gravel were observed. Material showing no signs of impact was returned to the preclearing locations and excess material that could not be replaced was containerized in a 55-gallon drum for waste characterization sampling and disposal.

CAMP and Special CAMP were implemented throughout the work day to ensure there were no impacts to potentially exposed populations. Volatile organic compounds (VOCs) and particulates (i.e., dust) were within applicable standards and additional mitigations were not necessary.


Anticipated Upcoming Work:

- CAMP will continue to be implemented to ensure there are no impacts to 3rd parties in the area.
