# State Superfund Site Reclassification Notice Class 2 to Class 4

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site, located on Malone Road, Victor, NY 14564, has been reclassified on the Registry as a Class 4 site as it no longer presents a significant threat to public health and/or the environment for the following reason(s):

- Implementation of remedial activities are as follows: a long-term groundwater, surface water and soil vapor monitoring program to verify that natural attenuation processes are occurring at the site, zero valent iron would be injected into the subsurface if monitoring indicates enhanced contaminant reduction is necessary, eleven homes within the investigation area were connected to the public water supply, a soil vapor intrusion evaluation would be completed for buildings developed on the site, notification, inspection and maintenance program for sixteen homes with sub-slab depressurization systems, and a monitoring program for homes without systems, would be implemented to address exposures related to soil vapor intrusion.
- Human exposures to residual contamination at the site are being addressed through the
  implementation of an environmental easement that will limit the use and development of the site to
  commercial or industrial use, and prohibit the use of groundwater at the site as a source of potable or
  process water without prior approval. Compliance with the approved Site Management Plan and annual
  certification by the property owner to the New York State Department of Environmental Conservation
  will ensure that the institutional and engineering controls remain effective.
- Remedial actions have been satisfactorily completed in accordance with the October 2009 Record of Decision and measures are in place to prevent human exposure to residual contamination at the site.


