Basis for Classification Change

Hazardous waste disposal at this site was addressed by implementation of the remedy identified for the site by the Record of Decision. All construction of the components of the site-wide remedy was completed no later than 2008. The SSD systems as-builts confirms that the remedy has been constructed consistent with the requirements in the ROD. The as-builts are in edocs. Management of contamination remaining at the site, including any required monitoring, is and has been controlled pursuant to a Site Management Plan (SMP). A copy of the SMP is in edocs. Institutional controls were required to ensure the protectiveness of the site. The required control, in the form of an environmental easement is in place. A significant threat to public health and the environment no longer exists at the site. The site is properly remediated and requires site management, therefore, it qualifies for Class 4 status on the Registry of Inactive Hazardous Waste disposal sites. Additional off-site soil vapor intrusion sampling will continue as a component of site management activities.

Based upon investigations conducted to date, the primary contaminant of concern for this site is tetrachloroethene (PCE). PCE was found in the on-site soil at concentrations well below the soil cleanup objective (SCO) for unrestricted use (1.3 ppm).

PCE was also found in groundwater at the site, moderately exceeding groundwater standards (typically 5 ppb), with a maximum concentration of 120 ppb. PCE from the site has migrated off-site and all appropriate actions have been taken to address exposures related to soil vapor intrution. Offsite monitoring of properties continues to address any uncertainity.


Site Health Assessment - Last Update: 02/19/2014

People are not drinking the contaminated groundwater at the site because the area is served by a public water supply that is not affected by site-related contamination. Volatile organic compounds in the groundwater may move into the soil vapor (air between soil particles), which in turn may move into overlying buildings and affect the indoor air quality. This process, which is similar to the movement of radon gas from the subsurface into the indoor air of buildings, is referred to as soil vapor intrusion. Sub-slab depressurization systems (systems that ventilate/remove the air beneath the building) have been installed in both on- and off-site buildings to address the potential for soil vapor intrusion to occur. The potential for soil vapor intrusion to occur in additional off-site buildings is continuing to be evaluated.

Remedy Description and Cost

Remedy Description for Operable Unit 01

The elements of the remedy are as follows:

- (1.) A remedial design program was implemented to provide the details necessary for the operation, maintenance, and monitoring of the remedial program.
- (2.) Continued operation of the sub slab depressurization (SSD) systems in the on-site building and one off-site building. These systems were installed in December 2005. In February 2006, additional indoor air sampling of structures adjacent and down gradient of the site was performed and actions were recommended to address soil vapor intrusion. Additional off-site soil vapor intrusion sampling will continue as a component of site management activities. If data indicate actions are necessary to address soil vapor intrusion, SSD systems or other appropriate actions will be offered to those building owners as part of the remedy.
- (3.) Continue groundwater monitoring.
- (4.) A site management plan was developed to: evaluate the potential for vapor intrusion for any buildings developed on the site, including provision for mitigation of any impacts identified; identify any use restrictions; and provide for the operation and maintenance of the components of the remedy.
- (5.) An environmental easement is in place that requires compliance with the approved site management plan; restricts the use of groundwater as a source of potable water, without necessary water quality treatment as determined by NYSDOH; and requires the property owner to complete and submit to the NYSDEC a periodic certification.
- (6.) The property owner will provide a periodic certification, prepared and submitted by a professional engineer or such other expert acceptable to the NYSDEC, until the NYSDEC notifies the property owner in writing that this certification is no longer needed. This submittal will contain certification that the institutional controls and engineering controls, are still in place, allow the NYSDEC access to the site, and that nothing has occurred that will impair the ability of the control to protect public health or the environment, or constitute a violation or failure to comply with the site management plan.
- (7.) The operation of the sub slab depressurization systems will continue until the remedial objectives have been achieved.



As mandated by Section 27-1305 of the Environmental Conservation Law (ECL), the New York State Department of Environmental Conservation (Department) must maintain a Registry of all inactive disposal sites suspected or known to contain hazardous waste. At your Department's request, we have reviewed the proposal to reclassify the referenced site from Class 2 to Class 4 on the NYSDEC's Registry of Inactive Hazardous Waste Disposal Sites. Specifically, we have reviewed the proposal to determine whether this reclassification is protective of public health. I understand that following the implementation of the site remedy (i.e., groundwater monitoring and soil vapor intrusion abatement), there is residual contamination remaining in groundwater and soil vapor. Human exposures to this residual contamination are being addressed as follows.

- <u>Groundwater</u>: Use of groundwater underlying the site is prohibited without necessary water quality treatment.
- <u>Soil Vapor</u>: The sub-slab depressurization systems that are addressing exposures related to soil vapor intrusion in on- and off-site buildings will continue to be operated and monitored. Air sampling of off-site buildings will resume in order to complete the site's soil vapor intrusion evaluation. If necessary, additional appropriate actions will be implemented to address exposures in these off-site buildings.
