State Superfund Site Classification Notice

The Inactive Hazardous Waste Disposal Site Program is New York State's superfund program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). The site identified above, and located on a map on the reverse side of this page, has been added to the Registry as a Class 2 site that presents a significant threat to public health and/or the environment for the following reason(s):

- The site is currently utilized for passive and active recreation with uses including sports fields, walking trails, playgrounds, picnic areas, a community pool, disc golf course, and a small pond. Based on investigations conducted to date, on-site soils and groundwater are contaminated with metals and semi-volatile organic compounds at levels exceeding applicable standards, criteria, and guidance. Glass manufacturing waste material, including ash, brick, and/or glass, was also observed at the site.
- The potential exists for people that disturb soils and any stockpiled materials related to intrusive work to be exposed to site-related contaminants through direct contact. Additional investigation is recommended to further define the nature and extent of contamination on and off the site, as well as to evaluate associated current and potential human exposures.

DEC will keep you informed throughout the investigation and cleanup of the site.


