**VIBRATION/SETTLEMENT MONITORING COMMENTS:**  
Settlement monitoring continues, very little movement observed at crack gauges. Have seen some temperature related movement. Data from Leica system shows normal temperature related oscillation. Sensor SP-07 was reconnected to the system which affected readings at the other sensors in the system. These fluctuations are not supported by the readings from the Leica system. The Geokon system will be re-plumbed and re-zeroed.  
Vibration monitoring is conducted daily within the former MGP structure and Water Street Wines & Spirits building. Multiple alert level exceedances 6/13 through 6/15 due to personnel working near the monitor. One stop work exceedance on 6/15 in the SE room due to personnel bumping the monitor.  
Turbidity monitoring conducted daily. No turbidity exceedances observed.

**AIR MONITORING COMMENTS:**  
AECOM on site performing CAMP and noise monitoring. No CAMP exceedances observed.

**SAFETY OBSERVATIONS/VIOLATIONS/COMMENTS**  
SES performing daily toolbox safety meetings. Approximately 47,250 site hours worked to date without incident.





