Declaration of Covenants and Restrictions

WHEREAS, the Property is subject to the provisions of a certain Order on Consent # B9-0335-90-05 dated July 25, 1993, between the New York State Department of Environmental Conservation (NYSDEC), the Town of Machias, and Declarant; and

WHEREAS, the Property has been impacted by the Machias Gravel Pit and is subject to restrictions and conditions as noted in the Record of Decision, dated November 1992, Schedule C, including monitoring which will continue on the Property until discontinued pursuant to NYSDEC approval.

Covenants and Restrictions

NOW, THEREFORE, in consideration of the foregoing premises, Declarant hereby declares the following:

- 1. No well for drinking water shall be drilled or otherwise constructed at, in or under the Property.
- 2. The provisions of this Declaration shall run with the Property and shall be binding upon Declarant and all others who may acquire an interest in the Property until such time as the groundwater has achieved applicable drinking water standards as confirmed in writing by the NYSDEC.
