WORK COMPLETED DURING THIS REPORTING PERIOD

The work related to each task performed this period is as follows:

Task 1: Work Plan:

EEEPC received comments and additional scope of work from NYSDEC and then submitted the revised work plan on April 26, 2007. The work assignment and budget as prepared was approved by NYSDEC on May 23, 2007. No further work is anticipated with Task 1 and is internally closed.

EEEPC has opened the project and is continuing the OM&M reporting function, development of the Site Management Plan (SMP), and the Periodic Review Report (PRR).

Task 2: Site Management:

Subtask 2.1.A - OM&M services.

The November 2007 OM&M report was issued on December 7, 2007. The remedial treatment system for Mr. C's was 100% operational for the month of November 2007. Approximately 672,600 gallons of groundwater was treated in the month of November 2007. The analytical monitoring program for October indicated that the parameters analyzed were in compliance with the current SPDES Discharge Equivalency Permit. The Agway site continues to be operational.

The subcontracts for the Iyer Environmental Group (IYER-OM&M Services) and Mitkem Corporation (Mitkem – analytical) were effective as of July 16, 2007. Both subcontractors are currently active and involved with the work assignment.

Subtask 2.1.B – Long-term Groundwater Monitoring Program

The field work is scheduled by EEEPC staff for performance of the long-term groundwater monitoring program was performed August 6-10, 2007. Turn around time of analytical samples is 21 days from receipt of samples. The laboratory performing the analytical services was the Mitkem Corporation. The analytical data results have been validated and the report is still being prepared. Anticipated issuance of the Groundwater Monitoring report is December 2007.

<u>Subtask 2.1.C – Program Air Monitoring and Evaluation Services</u>

No further work performed on the depressurization systems performed in October. The next indoor air testing work under this subtask is scheduled for the heating season of October 2009.

Subtask 2.1.D – Periodic Review Reports (PRR)

Initiate preparation of the PRR for submission in December 2007.

<u>Subtask 2.2 – Site Management Plan</u>

The SMP is currently under development by EEEPC. Draft Plan to be issued in December 2007.

Task 1.1: As of the November 2007 reporting period, approximately \$5,980 of the \$6,000 task budget, or 99.6%, has been spent.

Task 2.1: As of the November 2007 reporting period, approximately \$89,704 of the \$664,026 task budget or 13.83% has been spent.

Task 2.2: As of the November 2007 reporting period, approximately \$10,765 of the \$22,103 task budget or 48.7% has been spent.
