Site Description

The site is located at 584 and 586 Main Street within a light industrial and residential area in the Village of East Aurora. The property includes an active dry cleaning business (Mr. C's Dry Cleaners) within a one floor building on a concrete slab foundation and an adjacent paved parking lot. Odors detected in a nearby church daycare center were determined to be tetrachloroethylene (PCE) traced back to Mr. C's where still bottoms from the operation were disposed of into a dumpster in the parking lot prior to 1985. Condensate from the steam flushing and vacuuming process were disposed of in the sanitary sewers. The NYSDEC completed a Preliminary Site Assessment in July 1992 which confirmed groundwater and sanitary sewer contamination. Levels of groundwater contamination exceeding Class GA Groundwater Standards were found in a well closest to Mr. C's Dry Cleaners. A Remedial Investigation Feasibility Study (RI/FS) was completed in 1996 under State Superfund. A Record of Decision (ROD) was issued in March 1997 which required that in-situ air stripping wells be used to treat contaminated groundwater. An Explanation of Significant Differences (ESD) was issued in April 2000 which changed the selected site remedy to a typical groundwater extraction treatment system, in lieu of the originally proposed in-situ air stripping technology. In October 2000 the remedial design was completed in accordance with the selected ROD remedy and as modified in the ESD. Remedial construction was completed in August 2002. The treatment facility is currently being operated and monitored by the NYSDEC per the approved January 2008 Site Management Plan. The area adjacent to site is currently being evaluated for economic development. Officials from the Village of Aurora are working with the NYSDEC during development of building plans for the area.

Site Environmental Assessment

PCE and breakdown products originating from past disposal practices of a dry cleaning operation have contaminated groundwater at the site. Groundwater contamination is currently being treated in accordance with the selected remedy and the approved Site Management Plan (SMP) by pump and treat technology under NYSDEC management. Treated water is being sampled, monitored and discharged through a dedicated discharge line along Whaley Avenue to Tannery Brook off Ridge Road and in accordance with discharge limits established by the NYSDEC's Division of Water. Treated air is also being sampled, monitored and discharged in accordance with NYS guidelines. The treatment system has been determined to be satisfactorily Page 2 of 6

removing PCE and breakdown products from the groundwater and containing the contaminant plume as designed. To date, approximately 100 million gallons of groundwater have been removed and treated, which has resulted in approximately 1350 pounds of contaminants removed. Based on long-term groundwater monitoring program reporting, PCE and breakdown compound concentrations are declining. At treatment system startup contaminant concentrations averaged approximately 2000 UG/L. Most recently the average contaminant concentrations is averaging approximately 1400 UG/L (~ 30% decline). In 2004 the NYSDEC completed a soil vapor intrusion study within the downgradient residential area. Elevated levels of PCE were found in soil gas and indoor air at various locations within the groundwater plume. Mitigation of two structures, through the installation of sub-slab depressurization (SSD) systems, was completed in 2004 and 2005. Monitoring of the SSD systems is ongoing. This site no longer presents a significant threat to public health and/or the environment. All requirements of the original ROD and ESD have been met. The SMP was approved by the NYSDEC in January 2008.

Site Health Assessment

Subslab depressurization systems in one home and a church reduce exposure to contamination from soil vapor intrusion. Although, contaminated groundwater has impacted private wells these few wells are used for watering lawns, washing cars, and other non-potable purposes. Exposures via drinking water is not expected because the community is served by a public water supply and NYSDOH advised residents not to consume water from these wells.

Remedy Description and Cost

Remedy Description for Operable Unit 01

The Record of Decision for this project was signed 3/27/97. The selected remedy consisted of in-situ air stripping for the treatment of contaminated groundwater within the source plume. An Explanantion of Significant Difference (ESD) was issued in April 2000, which informed the public that the remedy now designed utilizes conventional pump and treat technology in lieu of in-situ air stripping.

Total Cost \$1,251,675

Remedy Description for Operable Unit 01A

Portable room air cleaners equipped with carbon filtration systems were installed in the basements to remove the PCE, as well as any other VOCs such as the potential PCE break down products, from the air in the basement. Since the basement is the point of entry for the contaminated air, these units were considered to be effective at eliminating the exposure pathway throughout the homes.

Periodic monitoring of the indoor air continued until the start of the remedial action, and the air cleaners remained in place until another SVI investigation was completed. One system has since been replaced by a SSDS and the other has been removed by the home owner. That home owner has since refused indoor air sampling and possible SSDS installation as well.

Remedy Description for Operable Unit 01B

A SVI study has been implemented and completed at the subject legacy site in accordance with DER-13 and DOH Guidance. Representatives from DOH have been involved with the implementation of the SVI including, but not limited to, review and approval of associated workplans and reports.

Specifically, the following tasks have been completed:1)March 2003 and Sept 03 - Indoor air sampling at First Presbyterian Church, 2)Jan 04 - Two air filtration systems installed in Church, 3)May 04 - Soil gas survey, groundwater sampling, and indoor air sampling of structures in vicinity of the site, 4)July 04 - Second round of soil gas sampling in vicinity of the site, 5)Sept 04 - SSDS installed in Church, and 6)Jan 05 - SSDS installed within 27 Whaley Street (residential structure). The existing SSDSs within the First Presbyterian Church and 27 Whaley Avenue are currently under site management.

Basis for Classification Change

Remedial construction of the groundwater (GW) pump and treat system was completed in 2002. GW treatment system is currently being operated, monitored and maintained by the NYSDEC per the approved January 2008 Site Management Plan (SMP). The GW treatment system will be operated until GW contaminant concentrations have reached unchanged levels for a sustained period of time and until such time that continued operation would not result in further significant contaminant removal. The site management plan includes a long term groundwater plan, soils management plan, and vapor mitigation plan. The NYSDEC has completed a soil vapor intrusion study within the downgradient residential area. As a result, mitigation of two structures, through the installation of sub-slab depressurization (SSD) systems, was completed in 2004-2005. Monitoring of the SSD systems is ongoing per the approved January 2008 SMP.

This site has been remediated in accordance with the selected ROD remedy and as modified in the April 2004 ESD. The remedial activities at this site have removed the significant threat. The site management plan will provide periodic verification.







In addition, soil vapor depressurization systems were installed in the impacted church and the private home in 2004 and 2005 respectively. The groundwater extraction and treatment system is currently being operated and monitored as required. Post remedial sampling has shown that the remedial actions are effectively reducing contamination in the groundwater and indoor air.

Site Description

The site is located at 584 and 586 Main Street within a light industrial and residential area in the Village of East Aurora. The property includes an active dry cleaning business (Mr. C's Dry Cleaners) within a one floor building on a concrete slab foundation and an adjacent paved parking lot.

Odors detected in a nearby church daycare center were determined to be tetrachloroethylene (PCE) traced back to Mr. C's where still bottoms from the operation were disposed of into a dumpster in the parking lot prior to 1985. Condensate from the steam flushing and vacuuming process were disposed of in the sanitary sewers.

An Explanation of Significant Differences (ESD) was issued in April 2000 which changed the selected site remedy to a typical groundwater extraction treatment system, in lieu of the originally proposed in-situ air stripping technology. In October 2000 the remedial design was completed in accordance with the selected ROD remedy and as modified in the ESD. Remedial construction was completed in August 2002.

The treatment facility is currently being operated and monitored by the NYSDEC per the approved January 2008 Site Management Plan. Site Environmental Assessment

PCE and breakdown products originating from past disposal practices of a dry cleaning operation have contaminated groundwater at the site. Groundwater contamination is currently being treated in accordance with the selected remedy and the approved Site Management Plan (SMP) by pump and treat technology under NYSDEC management. Treated water is being sampled, monitored and discharged through a dedicated discharge line along Whaley Avenue to Tannery Brook off Ridge Road and in accordance with discharge limits established by the NYSDEC's Division of Water. Treated air is also being sampled, monitored and discharged in accordance with NYS guidelines.

The treatment system has been determined to be satisfactorily removing PCE and breakdown products from the groundwater and containing the contaminant plume as designed. 


