Comments/Changes/Attachments: This site was found in excellent condition during the walkover on May 31st 2006. All pumps, pump vaults, collection system and related PLC (process logic controls) units are operational and effective. Collected leachate continues to be automatically discharged and treated at Love Canal. The gallonage is approximately 400K/yr. The cap is in good condition. Habitat programs are in place w/delayed mowing, bat and bird houses and lancer pea and wildflower plantings. River debris continues to obstruct the outfall due to the embayment configuration, river water direction and prevailing winds. The debris is cleared by OXY as necessary. The integrity of the perimeter fence and gates, are good. There were no breaches. NAPL recovery well NR-2 continues to produce. The total gallonage recovered to date from 2001 is approxiametely 37K. Some site indicator chemicals are above GW stds. at wells PCM 03, 04 and 05. The trends are consistent and not increasing.
