TERMINATION AND RELEASE OF ENVIRONMENTAL EASEMENT

This Termination and Release of Environmental Easement is made as of this 24th day of March 2016, by and between The People of the State of New York, acting through their Commissioner of the Department of Environmental Conservation ("NYSDEC" or the "Department") with its headquarters located at 625 Broadway, Albany, New York 12233, and Equity One (Northeast Portfolio) Inc. ("Grantor") with its offices located at 410 Park Avenue, Suite 1220, New York, New York 10022.

RECITALS

Sec 44 1. The Department and Grantor entered into that certain Environmental Easement, dated as of October 28, 2014 and recorded in the office of the Nassau County Clerk on July 22, 2015 in Liber 13152, Page 396 ("Environmental Easement"). Capitalized terms used herein without definition have the meanings ascribed to them in the Environmental Easement.

Block 67 2. Grantor is the owner of certain land known and designated on the tax map of the Village of Garden City as tax map parcel number: Section 44 Block 67 Lots 26-28, being the same as that property conveyed to Grantor by deed dated November 16, 2009 and recorded in the Nassau County Clerk's Office in Liber 12563, Page 14. The property subject to the Environmental Easement comprises approximately 21.9 +/- acres, hereinafter more fully described in Exhibit A (the "Controlled Property").

Lot 26 3. Pursuant to Sections 1, 2, 3, 4, and 5 of the Environmental Easement, Grantor granted the Department rights and interests that run with the land in perpetuity in order to provide an effective and enforceable means of encouraging the reuse and redevelopment of the Controlled Property at a level that has been determined to be safe for a specific use while ensuring the performance of maintenance, monitoring or operation requirements; and to ensure the potential restriction of future uses of the land that are inconsistent with the stated purpose.

27 4. Pursuant to Section 2 A of the Environmental Easement, the Controlled Property may only be used for Restricted Residential, Commercial and Industrial use described in 6 NYCRR §375-1.8(g) and may only be used consistent with controls set out in that Section 2 A of the Environmental Easement.

28 5. The Parties do hereby agree that there is no longer a need for any institutional controls, including, but not limited to, any use restrictions, or engineering controls at the Controlled Property.


6. Pursuant to Section 9 of the Environmental Easement, the Department agrees to terminate and release the Environmental Easement.

TERMINATION AND RELEASE OF ENVIRONMENTAL EASEMENT

- A. The above recitals are hereby incorporated into this Termination and Release of Environmental Easement.
- B. The Department confirms that the date hereof is the "Termination Date" and the Department accordingly hereby terminates and releases the Environmental Easement on the Controlled Property.
- C. Accordingly, as of the date hereof, the Environmental Easement is no longer of any force and effect. Any and all rights granted by the Grantor to the Department in that Environmental Easement are fully and completely terminated and the Department no longer retains any rights whatsoever arising from or in connection with either the Controlled Property or the Environmental Easement.
- D. This Termination and Release of Environmental Easement inures to and binds the parties hereto and their respective successors and assigns.
- E. This Termination and Release of Environmental Easement shall be governed by and interpreted in accordance with the laws of the State of New York.




