

### Interim Remedial Measure (IRM) Proposed to Address Brownfield Site Contamination; Public Comment Period Announced

The public is invited to comment on a proposed IRM being reviewed by the New York State Department of Environmental Conservation (NYSDEC) to address contamination related to the Former Avis Headquarters Site (“site”) located at 900 Old Country Road in Garden City, New York. #### The Proposed IRM

An IRM means activities to address both emergency and non-emergency site conditions, which can be undertaken without extensive investigation and evaluation, to prevent, mitigate, or remedy environmental damage or the consequences of environmental damage attributable to a site. The IRM proposed for the site includes excavation of soil from identified hot spot areas beneath the floor of the Cendant Building and the Manufacturing Building. Additionally, impacted soil will be removed from storm water drywells and leach pools. Equity One (Northeast Portfolio), Inc. (“applicant”) developed the proposed IRM after performing a detailed investigation of the site under New York’s Brownfield Cleanup Program.

The proposed IRM is described in a draft cleanup plan called an “IRM Work Plan.” The document is available for review at the location identified below under “Where to Find Information.”

**Brownfield Cleanup Program:** New York’s Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as “brownfields” so that they can be reused and redeveloped. These uses include recreation, housing, business or other uses.

A **brownfield** is any real property that is difficult to reuse or redevelop because of the presence or potential presence of contamination.

### **Summary of the Proposed Remedy**

The draft IRM work plan that identifies the proposed IRM has several goals:

- 1) identify cleanup levels to be attained or the process to be used to determine these levels
- 2) explain why the proposed IRM will protect public health and the environment
- 3) provide a detailed description of the proposed IRM.

Based on soil sampling results from the Remedial Investigation completed at the Site, a program of soil excavation has been proposed. The excavation will result in the removal of all soils that exceed the NYSDEC Part 375 Unrestricted Use standards.

Eight areas in the Cendant Building and three areas in the Manufacturing Building have been identified to have soil containing hydrocarbons, PCBs, metals or pesticides that exceed the Unrestricted Use standards. These areas will be excavated by backhoe generally to a depth of five feet. The soil will be loaded onto trucks for disposal at appropriate offsite facilities. The work will all occur onsite roughly concurrent with the demolition of the buildings in preparation for site reconstruction as a retail mall. Additionally, a total of 31 dry wells and leach pools have been found to contain hydrocarbons, PCBs, metals and pesticides above Unrestricted Use standards. Soil will be removed from all of these structures by vactor truck to the depth previously determined by soil sampling. Soil samples will be collected from the bottom and sides of all the excavated areas and structures to verify that remaining soil meets Unrestricted Use standards. The remedial excavation is not expected to impact anyone off site. A Community Air Monitoring Plan, and a Dust and Odor Control Plan will be implemented as part of the remedial excavation, as detailed in the IRM Work Plan that was submitted to NYSDEC.

### **Next Steps**

NYSDEC will consider public comments, revise the plan as necessary, and approve the proposed IRM. The New York State Department of Health (NYSDOH) must concur with the proposed IRM. The applicant will then implement the IRM, with oversight by NYSDEC and NYSDOH. It is estimated that activities to clean up the site will take about one month.

NYSDEC will keep the public informed during the cleanup of the site.

### **Background**

NYSDEC previously accepted an application from the applicant to participate in the Brownfield Cleanup Program. The application proposes that the site will be used for redevelopment as a retail shopping mall.

The 21.8 acre Site is located in a commercial and light industrial area south of Old Country Road and includes five buildings and a large parking lot. One three story building consists of offices. Three of the buildings in the center and southern portion of the site were used for electronics manufacturing and sonar testing for the military from the late 1940's into the 1960's. The same buildings were used from 1980 until 2001 as the headquarters for Avis Corp. and for rental car storage and maintenance. Past manufacturing operations have resulted in impacts by metals,

petroleum and chlorinated solvents to soil, soil vapor, and groundwater. The Site has been vacant since 2001, with the exception of an active furniture store.
