Investigation Continues at Brownfield Cleanup Site

Under direction and oversight by the NYS Department of Environmental Conservation (NYSDEC), Fifth XNY LLC ("the Applicant") will continue to conduct a detailed environmental study at the 1612 Fifth Avenue Brownfield Cleanup Program (BCP) site ("site") located in Islip, Suffolk County. Please see the map for the site location.

Investigation Work Plan

The investigation work plan for additional environmental sampling, called a "Remedial Investigation Work Plan (RIWP) Addendum," was submitted to NYSDEC under New York's BCP.

Highlights of the Site Investigation

The investigation will continue to define the nature and extent of contamination in soil, groundwater and any other parts of the environment that may be affected.

Past investigations at the site have determined that polycyclic aromatic hydrocarbons (PAHs) such as benzo(a)pyrene exist in surface soil and PFAS, such as PFOA and PFOS contamination exists in soil and groundwater at the site.

Key components of the additional investigation work include:

- Installing and sampling soil borings to identify possible on-site sources of contamination; and
- Installing and sampling ground water wells to monitor impacts from areas of concern from the site.

Next Steps

When the investigation is completed, a report will be prepared and submitted to NYSDEC that summarizes the results. NYSDEC will review the report, make any necessary revisions and, if appropriate, approve the report.

After the investigation, and if cleanup is necessary, a proposed cleanup plan, called a "Draft Remedial Action Work Plan" will be developed. The cleanup plan will include an evaluation of the proposed site actions, or recommend a no action or no further action alternative. The goal of the cleanup plan is to ensure the protection of public health and the environment. NYSDEC will present the proposed cleanup plan to the public for its review and comment during a 45-day comment period.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Site Description

The 21.6-acre site is currently inactive and zoned as industrial. The site is bordered by 5th Avenue to the east, Heckscher Avenue to the west and mixed industrial and commercial areas to the north and south. The site was previously owned and operated by Hubbard Sand and Gravel, a landscape and masonry supply company. Hubbard operated at the site as a sand mine from approximately 1947 through approximately 1963. Between 1963 and 1986 the western portion of the site was utilized as a municipal landfill and reportedly accepted large quantities of construction and demolition (C&D) debris.

Planned redevelopment includes warehousing.

A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by DEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
