### Remedy Proposed for Brownfield Site Contamination; Public Comment Period Announced

The public is invited to comment on a proposed remedy being reviewed by the New York State Department of Environmental Conservation (NYSDEC), in consultation with the New York State Department of Health (NYSDOH), to address contamination related to the 1675 Apartments site ("site") located at 1675-1679 Westchester Avenue, Bronx, NY. Please see the map for the site location. Documents related to the cleanup of this site can be found at the location(s) identified to the left under "Where to Find Information."

Based on the findings of the investigation, NYSDEC in consultation with the New York State Department of Health (NYSDOH) has determined that the site does not pose a significant threat to public health or the environment. This decision is based on the limited and low concentrations of contaminants in soil, groundwater and soil vapor identified at the site. The potential for off-site migration of site-related contaminants and human exposure will be mitigated through source removal, a cover system, and engineering and institutional controls at the site.

<u>How to Comment</u>: NYSDEC is accepting written comments about the proposed plan for 45 days, from **February 25** through **April 11, 2019**. The proposed plan is available for public review at the location(s) identified at left under "Where to Find Information." Please submit comments to the NYSDEC project manager listed under Project-Related Questions in the "Who to Contact" area at left.

<u>**Draft Remedial Work Plan:**</u> The proposed Restricted Residential Use remedy consists of:

- Excavating contaminated soil at the site to approximately 10 feet below surface grade across most of the site, followed by confirmation sampling to determine if the Restricted Residential Use Soil Cleanup Objectives (SCOs) were met;
- Removing and properly disposing of any Underground Storage Tanks and contaminated soil encountered during excavation;
- Backfilling of some excavated areas with clean fill approved by NYSDEC;
- Construction of site-wide cover system to allow for restricted residential use of the site. The cover system will consist of: (1) a minimum of two feet of clean soil with a demarcation barrier, with the upper six inches of sufficient quality to maintain vegetation; or (2) concrete building foundations and sidewalks/pathways that are a component of site development;
- Imposition of Institutional Controls in the form of an Environmental Easement (EE) and a site-specific Site Management Plan (SMP).
  - The EE will require: (1) submittal of periodic certifications to NYSDEC; (2) restrict use of the site for restricted residential use, subject to local zoning; (3) restrict the use of groundwater as source of potable or process

water without water quality treatment, as determined by NYSDOH; and (4) require compliance with the SMP;

> The SMP will include, but not limited to: (1) an excavation plan for future excavation in areas of remaining contamination; (2) a monitoring plan to assess performance and effectiveness of the remedy; (3) a provision for investigating the potential for soil vapor intrusion at any occupied buildings on the site, including any necessary action to address exposures; and (4) steps necessary for periodic reviews and certification of the ICs and ECs.

The proposed remedy was developed by 1675 JV Associates LLC ("applicant") after performing a detailed investigation of the site under New York's Brownfield Cleanup Program (BCP).

Next Steps: NYSDEC will consider public comments, revise the cleanup plan as necessary, and issue a final Decision Document. NYSDOH must concur with the proposed remedy. After approval, the proposed remedy becomes the selected remedy. The applicant(s) may then design and perform the cleanup action to address the site contamination, with oversight by NYSDEC and NYSDOH.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

<u>Site Description</u>: The site is an undeveloped parcel of approximately 36,865 square feet. It is identified as Bronx Borough Tax Block 3780, Lot 1 on the New York City Tax Map and formerly comprised Lots 1 and 51. The site consists of concrete-paved areas on the southern and southeastern portions, at the location of the former site building, that is approximately 8.5 feet below sidewalk grade. The site was formerly developed with a building fronting Westchester Avenue until its demolition between September and October 2018. The site is surrounded by residential and commercial development.

<u>Summary of the Investigation</u>: The primary contaminants of concern at the site are polycyclic aromatic hydrocarbons and metals (arsenic, barium, lead and mercury), in the site-wide fill material and on-site groundwater. Petroleum related Volatile Organic Compounds (VOCs) and chlorinated VOCs are also present, to a limited extent, in the soil vapor at the site.

Brownfield Cleanup Program: New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by NYSDEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
