Introduction

P.W. Grosser Consulting, Inc. (PWGC) has prepared this monthly progress report, on behalf of GC Fordham Road Development LLC, to summarize Brownfield Cleanup Program (BCP) related work performed at the 608-610 East Fordham Road Site ("Site") for the month of May 2023.

The Site is in the County of Bronx, New York and is identified as Block 3078, Lot 16 on the New York City Tax Map. The property is bounded by East Fordham Road to the north, Hughes Avenue to the east, a residential building to the south, and a commercial building to the west. A site location map is included as **Figure 1**. The site was formerly utilized for commercial purposes. Proposed plans for the site include demolition of the existing structure and construction of an eight-story residential building with a full cellar.
