Draft Investigation Work Plan for Brownfield Site Available for Public Comment

The public is invited to comment on a draft work plan being reviewed by the New York State Department of Environmental Conservation (NYSDEC) to investigate the Lafayette Site B site ("site") located at 1931 Lafayette Avenue, Bronx, NY, 10473. Please see the map for the site location.

Draft Investigation Work Plan

The draft investigation work plan, called a "Remedial Investigation Work Plan," (RIWP) was submitted to NYSDEC under New York's Brownfield Cleanup Program. The investigation will be performed by GDC Strada Castle Hill JV I LLC ("applicant") with oversight by NYSDEC and the New York State Department of Health (NYSDOH).

NYSDEC is accepting written comments about the Draft RIWP for 30 days, from August 14, 2025 through September 13, 2025.

Highlights of the Proposed Site Investigation

The investigation will define the nature and extent of contamination in soil, surface water, groundwater and any other parts of the environment that may be affected.

Previous investigations have detected semivolatile organic compounds (SVOCs) and metals in soil on site. The groundwater investigation detected manganese in groundwater. The soil vapor investigation detected petroleum-related VOCs and chlorinated VOCs (CVOCs).

Key components of the investigation work include:

- Drilling and collecting samples from soil borings to identify possible onsite sources of contamination;
- Collecting soil vapor samples; and
- Installing groundwater wells and sampling groundwater to monitor impacts from areas of concern both onsite and offsite.

Next Steps

NYSDEC will consider public comments, revise the plan as necessary, and approve the work plan. NYSDOH must concur with the plan. After the work plan is approved, the activities detailed in the work plan will be implemented.

When the investigation is completed, a report will be prepared and submitted to NYSDEC that summarizes the results. NYSDEC will review the report, make any necessary revisions and, if appropriate, approve the report.

After the investigation, a proposed cleanup plan, called a "Draft Remedial Action Work Plan" will be developed. The cleanup plan will include an evaluation of the proposed site actions, or recommend a no action or no further action alternative. The goal of the cleanup plan is to ensure the protection of public health and the environment. NYSDEC will present the proposed cleanup plan to the public for its review and comment during a 45-day comment period.

NYSDEC will keep the public informed throughout the investigation and cleanup of the site.

Site Description

The site is approximately 0.472 acres and is identified as Block 3672 and p/o Lot 20 on the Bronx Tax Map. Currently, the site is utilized as a parking lot for the adjacent offsite multifamily residential building. The majority of the site is paved with asphalt and concrete, with limited areas of landscaping.

The proposed development will include the construction of a 21-story mixed use building containing approximately 200 affordable units.

Brownfield Cleanup Program

New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by NYSDEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
