OBSERVATIONS, DISCUSSIONS, TEST RESULTS, ETC.: Langan Engineering, Environmental, Surveying, Landscape Architecture and Geology, D.P.C. (Langan) was present to document site remediation in accordance with the New York State Department of Environmental Conservation (NYSDEC)-approved Remedial Action Work Plan (RAWP) for the BCP Site No. C224314. Site Activities • Bauer Structures (Bauer) excavated an about 40-foot-long by 3-foot-wide trench to about 3 feet below grade surface (bgs) in the central part of the site for plastic electrical conduit installation. Excavated material was screened for odors, staining, and organic vapors using a photoionization detector (PID). Evidence of impacts was not observed. ◦ Excavated material consisted of previously imported clean fill from Evergreen Recycling of Corona (EROC) in Flushing, NY, and recycled concrete aggregate (RCA) from the DOT Stockpile in Brooklyn, NY and was stockpiled in the central part of the site for future placement. • Bauer installed formwork in the northwestern and western parts of the site. ◦ During pile cap formwork installation, waterproofing/vapor barrier membrane (Preprufe 160R Plus) was installed on vertical walls within the formwork. • Bauer backfilled over plastic electrical conduits with previously imported and stockpiled clean fill from EROC in Flushing, NY in an about 10-foot-long by 4-foot-wide area from about 3 to 4 feet bgs to grade in the central part of the site. • Reliant Electrical Cont. Inc. (Reliant) installed plastic electrical conduits in the central and southern parts of the site. • Bauer backfilled an about 40-foot-long by 60-foot-wide area with between 8 and 12 inches of previously imported and stockpiled ASTM #5 stone in the southeastern part of the site for the installation of the sub-membrane depressurization system (SMD). • Bauer placed filter fabric and 4-inch perforated piping in an about 30-foot-long by 60-foot-wide area in the eastern part of the site for the installation of the SMD system. • Bauer utilized dewatering sumps in the shoring box in the northwestern part of the site to remove the excess rainwater from heavy precipitation. The extracted groundwater was collected and sent through a treatment system before the effluent was discharged to the NYC Department of Environmental Protection (DEP) combined sewer system (via the catch basin located along the eastern side of the		

intersection between Huntington Street and Smith Street). The dewatering and effluent discharge activities were performed in accordance with NYCDEP Dewatering Permit No. C001565643.

CAMP Activities

Community air monitoring was performed at the perimeters of the site at two locations (upwind and downwind) for particulate matter less than 10 µm in diameter (PM10) and volatile organic compounds (VOC).

- VOC and PM10 concentrations were not recorded above the action levels established in the site Community Air Monitoring Plan (CAMP).
- Dust was not observed migrating off-site throughout the day.
- Refer to the attached Daily Air Monitoring Report for summary and raw CAMP results.

Anticipated Activities

- Bauer will continue installation of foundation elements.

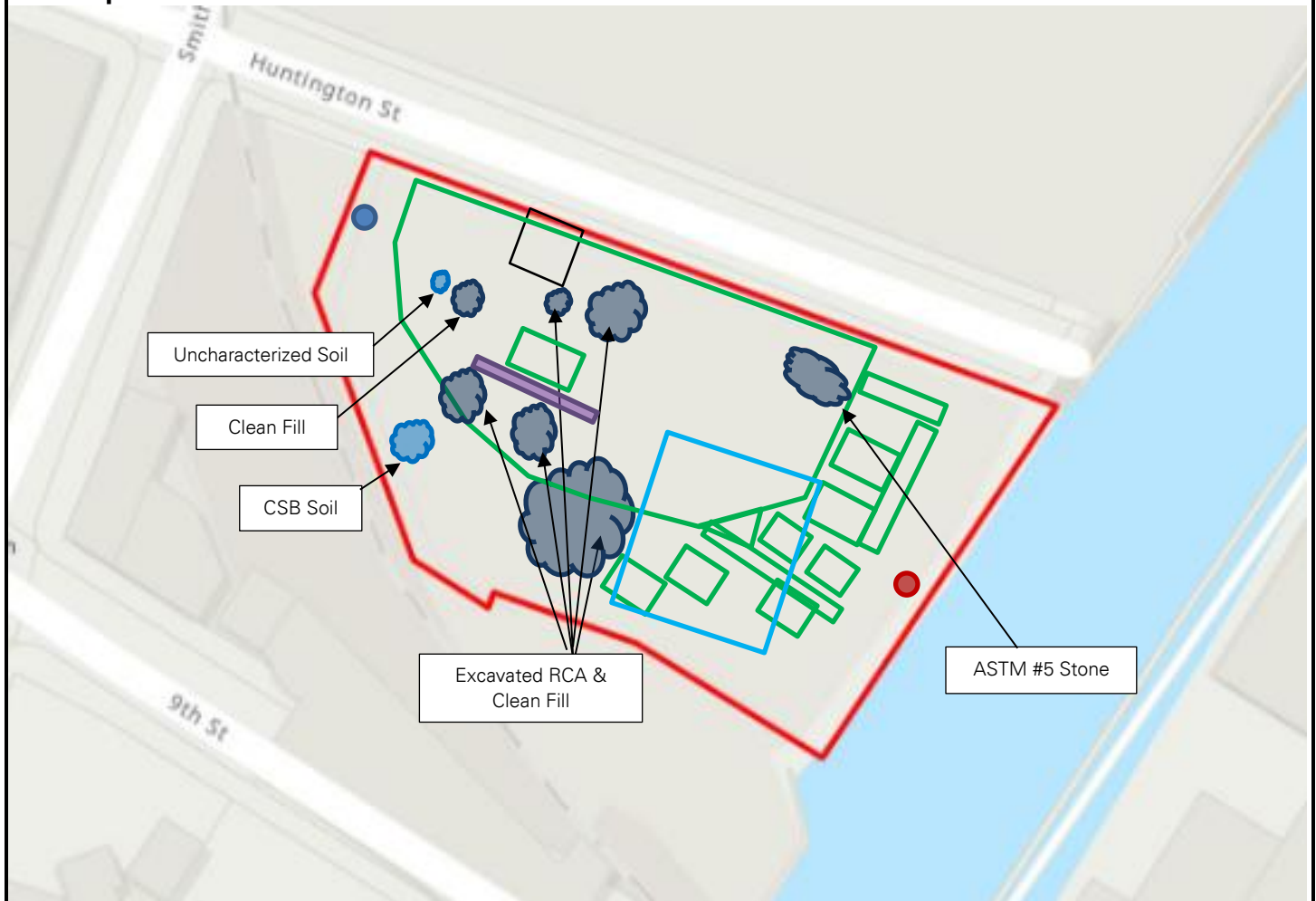


Photo 1: Bauer excavating a trench in the central part of the site for plastic electrical conduit installation (facing south).

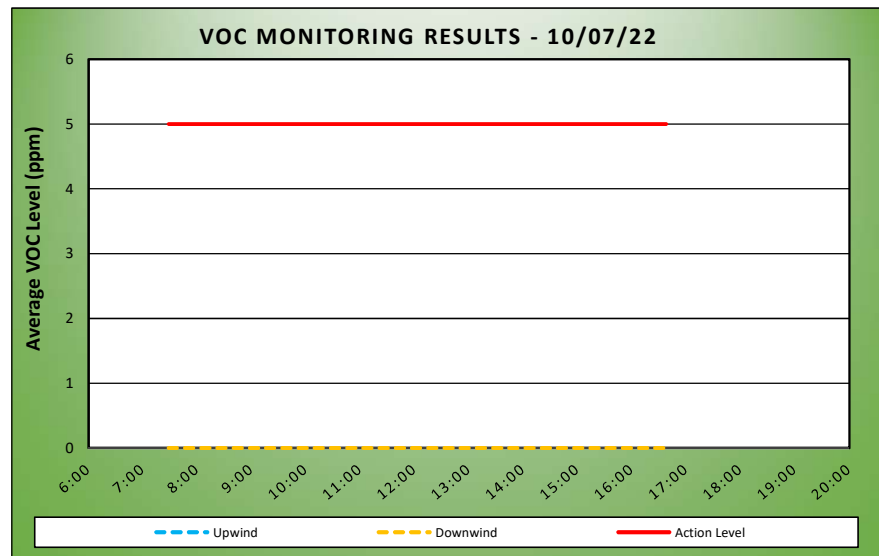
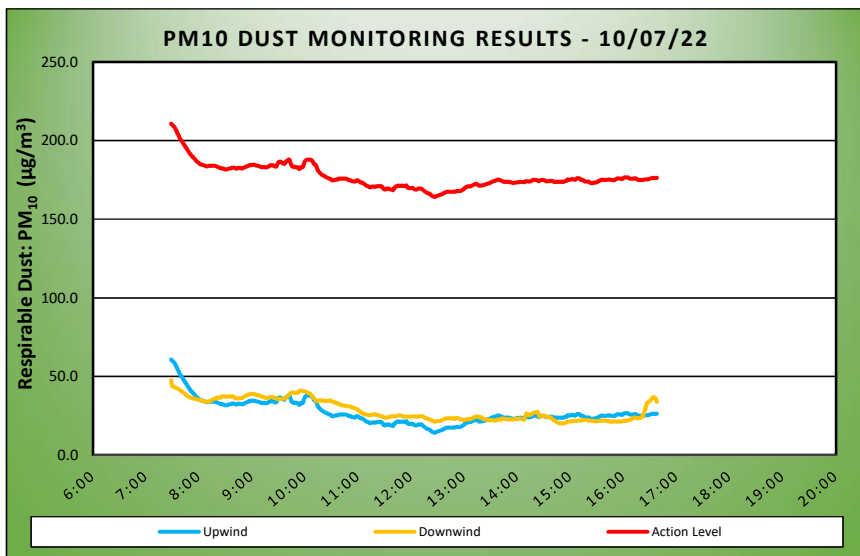
