OBSERVATIONS, DISCUSSIONS, TEST RESULTS, ETC.: Langan Engineering, Environmental, Surveying, Landscape Architecture and Geology, D.P.C. (Langan) was present to document site remediation in accordance with the New York State Department of Environmental Conservation (NYSDEC)-approved Remedial Action Work Plan (RAWP) for the BCP Site No. C224314. Site Activities - Bauer Structures (Bauer) placed chopped concrete in a roll off container in the center of the site in preparation for future off-site disposal. - Baurer removed formwork from the concrete slab. Sampling - No samples were collected. CAMP Activities Community air monitoring was performed at the perimeters of the site at two locations (upwind and downwind) for particulate matter less than 10 µm in diameter (PM10) and volatile organic compounds (VOC). - VOC and PM10 concentrations were not recorded above the action levels established in the site Community Air Monitoring Plan (CAMP). - Dust and odors were not observed migrating off-site throughout the day. - Refer to the attached Daily Air Monitoring Report for summary and raw CAMP results. Anticipated Activities - Bauer will continue to strip formwork.

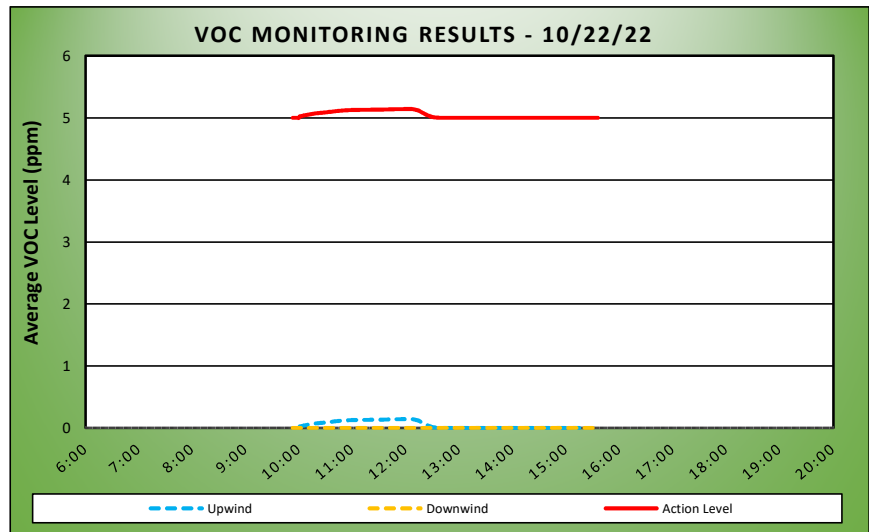
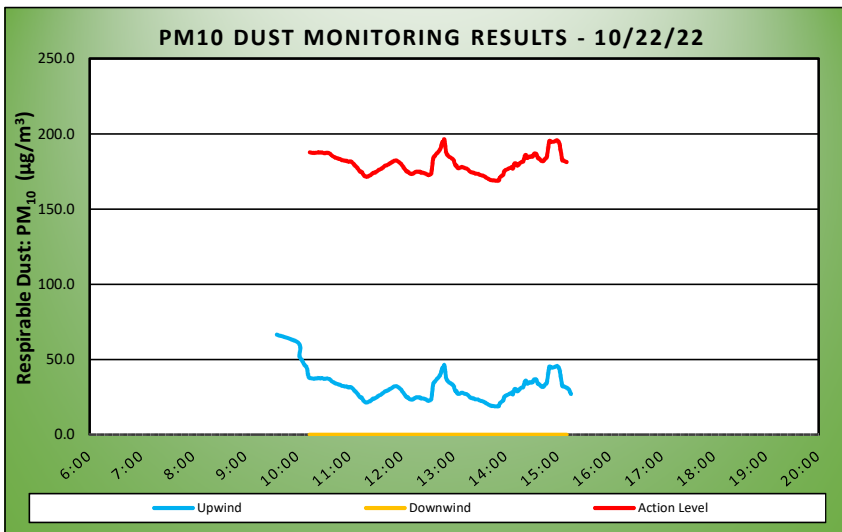
