Work Activities Performed:

- Vektor mobilized at the Site to oversee the export of C&D debris in the southwestern portion of the Site (D-1 through G-4). KMI exported 21 trucks with C&D to the Allocco Recycling LTD located at 540 Kingsland Avenue, Brooklyn, NY 11222.
- One upwind and two downwind CAMP stations were set up as described below.
- Water was utilized as a suppressant to prevent dust generation during concrete transport.
- No odors or evidence of release were observed during the work.
- As part of the remedial program, to evaluate the remedy with respect to green and sustainable remediation principles, an environmental footprint analysis was completed. The environmental footprint analysis was completed using an accepted environmental footprint analysis calculator, SEFA (Spreadsheets for Environmental Footprint Analysis, USEPA). Water consumption, greenhouse gas emissions, renewable and non-renewable energy use, waste reduction, and material use were estimated, and goals for the project related to these green and sustainable remediation metrics. The following footprint was calculated at the Site. It was estimated that approximately 15,463 pounds of greenhouse gas emissions (GHG) emissions (carbon dioxide equivalents of global warming potential), 88 pounds of NOx emissions, 41 pounds of SOx emissions, 211 pounds of particulate matter (PM) emissions, and 1 pounds of hazardous air pollutants (HAPs) were emitted during the reporting period at the Site. The majority of the emitted pollutants were due to off-site scopes, including laboratory analysis.

Community Air Monitoring Program (CAMP)

Upwind and downwind CAMP stations were placed near the perimeters of the Site during intrusive work. A downwind CAMP was positioned in the central portion of the Site, and a second downwind CAMP station was in the southern portion of the Site along the adjoining neighboring building. The upwind CAMP station was in the northern portion of the Site.

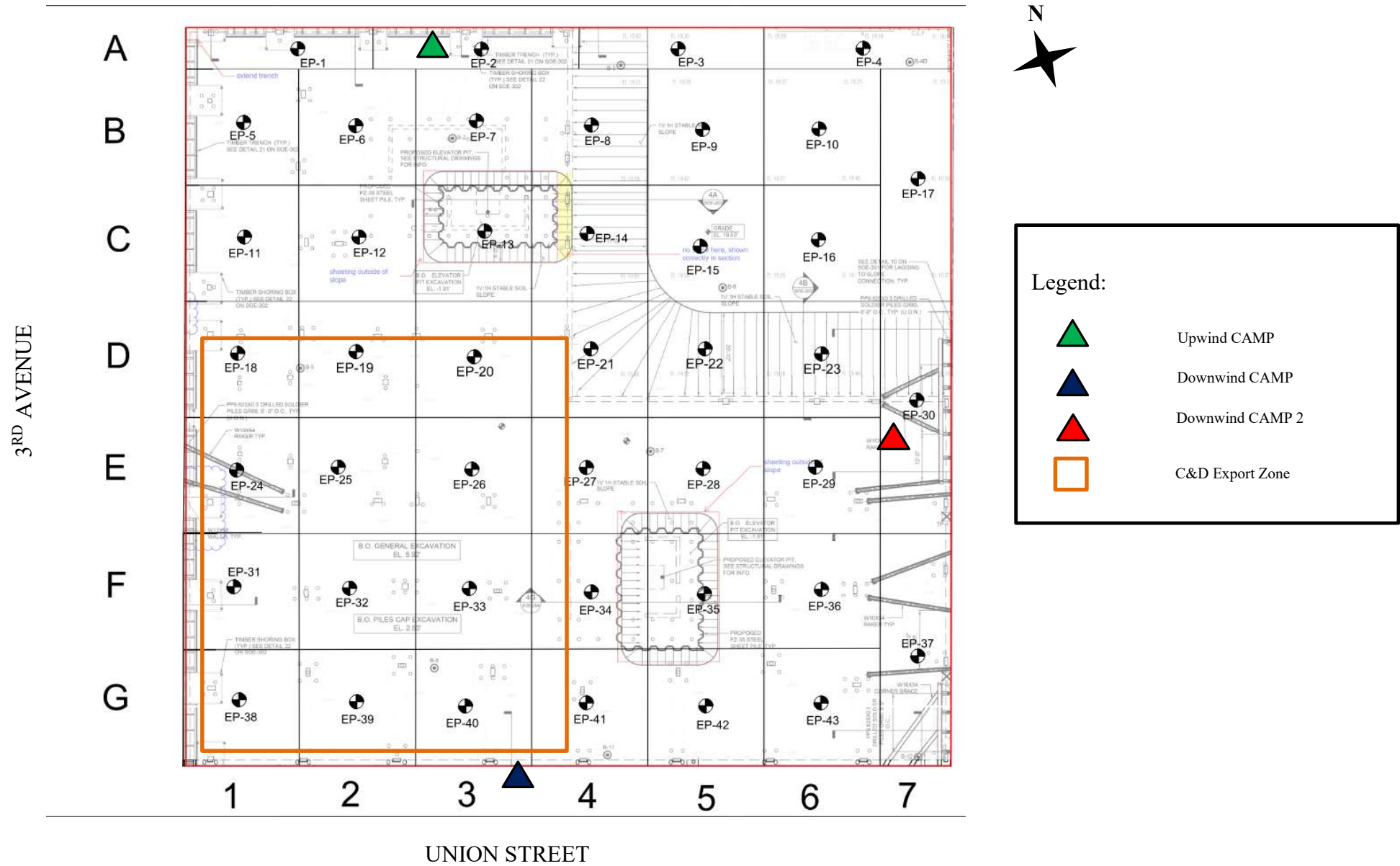
