NYSDEC Certifies Cleanup Requirements Achieved at Brownfield Site

The New York State Department of Environmental Conservation (NYSDEC) has determined that the cleanup requirements to address contamination related to the 401 West 207th Street Redevelopment site ("site") located at 401 West 207th Street, Manhattan, NY, 10034, under New York State's Brownfield Cleanup Program (BCP) have been met. Please see the map for the site location.

The cleanup activities were performed by 401 W 207th Realty LLC, 3761 207th Street Realty LLC, and 3761 10th Avenue Realty Corp. (collectively and individually, "applicant") with oversight provided by the New York State Department of Environmental Conservation (NYSDEC). NYSDEC has approved a Final Engineering Report (FER) and issued a Certificate of Completion (COC) for the Site.

Completion of the Project: The following activities have been completed to achieve the remedial action objectives:

- Excavation and off-site disposal of approximately 20,600 cubic yards of soil exceeding the unrestricted use soil cleanup objectives (SCOs) down to 28 feet below grade;
- Installation of support wall and dewatering systems to facilitate the soil excavation and treatment of water accumulated prior to discharge to a NYSDEC-approved city sewer;
- Collection of post-remedial soil samples to confirm removal of all contaminated fill material and to confirm achievement of a Track 1 cleanup;
- Removal and decommissioning of two underground storage tanks and associated appurtenances;
- An evaluation of the potential for soil vapor intrusion into the new building, which determined that vapor intrusion is not an issue at this Site.

BROWNFIELD CLEANUP PROGRAM

Final Engineering Report Approved: NYSDEC has approved the FER, which:

- 1) Describes the cleanup activities completed.
- 2) Certifies that cleanup requirements have been achieved for the Site.
- 3) No institutional or engineering controls have been put in place on this Site.

Next Steps: With its receipt of a COC, the applicant is eligible to redevelop the Site. In addition, the applicant is eligible for tax credits to offset the costs of performing cleanup activities and for redevelopment of the Site. A COC may be modified or revoked if, for example, there is a failure to comply with the terms of the order or agreement with NYSDEC.

Site Description: The Site is located at 401 West 207th Street in the Inwood neighborhood of Manhattan and is identified as Block 2189, Lot 60 on the New York City Tax Map. The site is about 27,450 square feet (0.633 acres) and is bound to the north by the New York City Transit Authority 207th Street Train Yard; to the south by West 207th Street followed by 16-story and 13-story mixed-use residential and commercial buildings (BCP Site Nos. C231147 and C231144); to the east by 9th Avenue followed by a construction site for a 30-story residential building (BCP Site No. C231102); and to the west by the railroad yard followed by 10th Avenue and above ground subway tracks for the 1 train.

The remedial program achieved a Track 1 cleanup which allows for unrestricted use of the Site. The proposed redevelopment plan includes a 17 - story mixed - use commercial/residential building.

A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by NYSDEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
