Interim Remedial Action to begin at New York Express Dry Cleaners Site

The New York State Department of Environmental Conservation (NYSDEC) working cooperatively with the New York State Department of Health (NYSDOH), has approved an application for the Brownfield Cleanup Program for the New York Express Dry Cleaners Site (Site No. C241050) and have reviewed a soil vapor extraction system as an Interim Remedial Measure (IRM).

Site Description: New York Express Dry Cleaners Site is an active commercial dry cleaner situated within the larger Fresh Meadows area of Queens County, New York. The site, a retail store of approximately 3000 square feet in size, has had an active dry cleaning operation since at least 1983. Express Dry Cleaners is located in a shopping center on the northwest corner of 188th Street and 73rd Avenue

The Planned Action: To design, install and implement an IRM system that would include a soil vapor extraction system (SVE) to recover volatile organic compounds (VOCs) from the site's soil. Additional soil vapor investigations will also be conducted.

Previous Investigations: A Phase 1 Environmental Assessment (July 1997) indicated potential environmental issues associated with New York Express Dry Cleaners Site, specifically an underground storage tank used to store heating oil. Subsequent Phase 2 environmental assessments as well as removal of the tank revealed levels of tetrachloroethene (PCE) and trichloroethene (TCE) (constituents typical of dry cleaning operations) in the site's soil at levels above the State's Soil Clean-up Standards. A remedial investigation (August 2004 to October 2004) including well installation, groundwater monitoring and soil gas sampling produced results that supported the use of an SVE system as an effective way to remove VOCs from the contaminated soil.
