AMENDED BROWNFIELD SITE CLEANUP AGREEMENT

WHEREAS, C.E. Flushing, LLC, with offices located at 118-35 Queens Boulevard, Forest Hills, New York 11375, is currently participating in the Brownfield Cleanup Program relative to 13.48 acres of real property located NW Corner of College Point Avenue and 40th Road, Flushing, Queens County, 11375, at latitude 40.7574E and longitude -73.8337E, and designated Tax Block 5066, Lots 1, 79, and 91 (the "Property"); and

WHEREAS, the Site will be developed as four parcels, as designated on the map attached Exhibit "A" as Parcels "1", "2", "3", and "4"; and

WHEREAS, Brownfield Site Cleanup Agreement, Index No. W2-1027-04-10, for Site No. C241051, dated December 23, 2004 (the "BCA" or the "Agreement") is applicable to Parcel 1. A metes and bounds description of Site No. C241051 is attached as Exhibit "B"; and

WHEREAS, the BCA was amended on June 14, 2005 to add C.E. Flushing Parking, LLC; C.E. Flushing Commercial East, LLC; and C.E. Flushing Residential East I, LLC as Volunteers; and

WHEREAS, the BCA was further amended on December 11, 2006 to add Target Corporation as a Volunteer; and

WHEREAS, a certified application was submitted to the Department on January 8, 2007 to a Flushing Town Center III, LP and Allied Flushing Corporation, both are newly-formed affiliate entities of C.E. Flushing, LLC with a mailing address c/o Muss Development Corp., 11835 Queens Boulevard, Forest Hills, New York 11375, as additional Volunteers to the BCA; and

WHEREAS, upon consideration of the factors enumerated in ECL 27-1407(8) and (9), the Department made a determination, based upon consideration of the applications to add the Additional Applicants, that such Additional Applicants are eligible to participate in the BCP as a Volunteer as defined in ECL 27-1405(1)(b),

NOW THEREFORE, in consideration of and in exchange for the mutual covenants and promises, the parties agree to the following:

- 1. Flushing Town Center III, LP, and Allied Flushing Corporation are added as Volunteers to the BCA; and
- 2. The Agreement, the June 14, 2005 Amendment, the December 11, 2006 Amendment and this Amendment to the Agreement shall constitute the entire Agreement between the parties with all the terms and conditions of the Agreement, except as provided herein, remaining in full force and effect; and
- 3. The effective date of the Amended Brownfield Site Cleanup Agreement shall be the date it is executed by the Commissioner or the Commissioner's designee.

Map



Metes and Bounds

Flushing Industrial Park (Eastern), Parcel 1 BCP Site No. C241051 Metes and Bounds Description

There follows a suggested technical description of part of the property shown on map # 38448-F prepared by Wohl & O'Mara, LLP.

Beginning at the point formed by the intersection of the southerly side of Roosevelt Avenue (120.00 feet wide) with the westerly side of College Point Boulevard (100.00 feet wide).

- 1) Running thence southerly along said westerly side of College Point Boulevard a distance of 312.18 feet to the point formed by the intersection of said westerly side of College Point Boulevard with the northwesterly side of 40 th. Road.
- 2) Thence southwesterly along said northwesterly side of 40 th. Road 734.88 feet to a point.
- 3) Thence northerly forming an interior angle of 64 degrees 25 minutes 30 seconds and a distance of 299.40 feet to a point.
- 4) Thence easterly forming an interior angle of 90 degrees 00 minutes 00 seconds and a distance of 160.00 feet to a point.
- 5) Thence northerly forming an interior angle of 90 degrees 00 minutes 00 seconds and a distance of 108.00 feet to a point.
- 6) Thence easterly forming an interior angle of 90 degrees 00 minutes 00 seconds and a distance of 100.00 feet to a point.
- 7) Thence northerly and perpendicular to Roosevelt Avenue 222.00 feet to a point on the southerly side of Roosevelt Avenue (120.00 feet wide).
- 8) Thence easterly along southerly side of Roosevelt Avenue (120.00 feet wide) 398.00 feet to the point or place of beginning.
