The Department will develop a fact sheet announcing the issuance of the COC and distribute the fact sheet to the Department's remediation listserv for Queens County within 10 days of issuance of the COC.

Please be reminded that Eastern Emerald Group LLC has satisfied the Remedial Action Objective for soil vapor at the Site on the condition that future sub-grade parking provides continuous ventilation and complies with the New York City Mechanical Code. When building construction begins, or if the current building plans are modified, Eastern Emerald Group LLC is required to submit a "Change of Use" notification to the Department to ensure compliance with the COC. Please also note that per Title 6 of the Official Compilation of Codes, Rules and Regulations of the State of New York Section 375-1.9(e)(iii), a COC may be modified or revoked by the Department upon a finding that there was a misrepresentation of a material fact tending to demonstrate that the cleanup levels at the Site were reached.
