1. Introduction

In accordance with Article XI – Progress Reports of the 03 February 2016 Brownfield Cleanup Agreement (BCA) for the above-referenced site, Langan Engineering, Environmental, Surveying, Landscape Architecture and Geology, D.P.C. (Langan) prepared this monthly progress report on behalf of PLAX B26, LLC (Participant) to summarize the work performed at 5-25 46th Avenue, Long Island City, New York (the site) during December 2025.

The site (Block 26, Lots 17 and 21) is in the Long Island City neighborhood of Queens, New York and encompasses an area of about 92,940 square-feet (± 2.13 -acre) lot. The site is located on the city block bordered by Anable Basin to the north, Vernon Boulevard on the east, 46th Avenue to the south, and 5th Street to the west. The site is currently occupied by 1-story manufacturing-zoned building and a parking lot. Elevations at the site range from elevation (el.) 9 North American Vertical Datum of 1988 (NAVD88) in the southeast part of the site near 46th Avenue to about el. 5.5 in the northwest part of the site near Anable Basin.
