Cleanup Action Completed at Brownfield Site

Action has been completed to address the contamination related to the 28-90 Review Avenue Development site ("site") located at 28-90 Review Avenue, Queens, Queens County under New York State's Brownfield Cleanup Program (BCP). Please see the map for the site location.

Cleanup activities were performed by 28-90 Review Avenue Owner, LLC and 28-90 Review Ave Property Owner LLC ("applicants") with oversight provided by the New York State Department of Environmental Conservation (NYSDEC). The applicants have submitted a proposed Final Engineering Report (FER) for NYSDEC review which states that cleanup requirements have been or will be achieved to fully protect public health and the environment for the proposed site use.

Highlights of the Site Cleanup

The following activities have been or will shortly be completed to achieve the remedial action objectives:

- Excavation and off-site disposal of contaminated soil that exceeds the commercial soil cleanup standards in the top one foot of the site as well contaminated soil in the vicinity of metals hotspots and underground storage tanks. Clean fill was brought in to replace the excavated soil and to establish the design grades at the site.
- Implementation of in-situ (i.e. in place and underground) soil stabilization and solidification within the extents of observed non-aqueous phase liquid.
- Decommissioning, removal and disposal off-Site of four previously unknown underground storage tanks.
- An active sub-slab depressurization system installed beneath the concrete slab in the enclosed occupiable portions of the building to protect against soil vapor intrusion.
- The new development will maintain a site cover, which consists of the structures (buildings, pavement, sidewalks) comprising the site development and a 1-foot clean soil cover in landscaped areas placed over a demarcation layer.
- Development of a Site Management Plan (SMP) for long-term management of residual contamination as required by the Environmental Easement, including plans for: (1) Institutional and Engineering Controls (IC/ECs); (2) monitoring; (3) operation and maintenance; and (4) reporting.
- An Environmental Easement was recorded to prevent future exposure to any contamination remaining at the site and to ensure implementation of the SMP.

Next Steps

When NYSDEC approves the FER, it will be made available to the public (see "Where to Find Information"). NYSDEC then will issue a Certificate of Completion (COC) that will be announced in a fact sheet. The applicants would be able to redevelop the site after receiving a COC. In addition, the applicants will be eligible for tax credits to offset a portion of the costs of performing cleanup activities and for redevelopment of the site.

Site Description

The 3.95-acre site is located in the Long Island City neighborhood of Queens, New York at 28-90 Review Avenue. The site is bounded by 29th Street to the east, an at-grade Long Island Rail Road Metropolitan Transportation Authority (LIRR MTA) railroad to the south, the Dutch Kills to the west, and an asphalt parking lot to the north. Historic site use has included a Texaco petroleum tank farm which operated between approximately 1915 and 1971. Subsequent operations include a trucking depot and automobile repair and storage facility.

The site has been cleaned up to all for commercial or industrial use. Upon completion of construction, the development will consist of a five-story commercial and industrial warehouse building.

New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives or other health-based or environmental standards, criteria or guidance adopted by DEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.
