Assurance Project Plan (QAPP) were received from the NYSDEC Chemist on May 28, 2021. SESI hosted a conference call on June 8, 2021 to discuss the May 25 and May 28 comments and received follow-up comments from the NYSDEC on June 9, 2021.

SESI will review and address the comments received to date. Comments from the NY Department of Health (DOH) are pending per communication from the NYSDEC. A conference call will be scheduled to discuss the comments.
