AKRF, Inc. (AKRF) has prepared this Monthly Progress Report to summarize work performed at the abovereferenced New York State Department of Environmental Conservation (NYSDEC) Brownfield Cleanup Program (BCP) site (the "Site"). The Site location is shown on Figure 1. The following activities were conducted in October 2021:

- AKRF submitted the revised Remedial Investigation Report (RIR) to NYSDEC on October 18, 2021.
- AKRF submitted the draft Off-site Soil Vapor Intrusion Work Plan (OSVIWP) to NYSDEC on October 25, 2021.
- On October 25, 2021, AKRF and the BCP Applicant participated in a conference call with NYSDEC to review the draft Remedial Action Work Plan (RAWP) comments and proposed schedule for the upcoming public comment period.
- AKRF submitted the revised Remedial Action Work Plan (RAWP) to NYSDEC on October 28, 2021.

The following activities are planned for November 2021:

- Pre-demolition surveys and demolition of the Site buildings will continue.
- The 45-day public comment period for the draft RAWP is slated to begin on November 3, 2021.
- NYSDEC is anticipated to issue approval of the draft RIR and comments on the draft OSVIWP.
