Cleanup Action Completed at Brownfield Site

Action has been completed to address the contamination related to the 68-19 Rego Park LLC site ("site") located at 68-19 Woodhaven Boulevard, Queens, NY under New York State's Brownfield Cleanup Program (BCP). Please see the map for the site location.

Cleanup activities were performed by SMJ Woodhaven Owner LLC, 68-19 Woodhaven Housing Development Fund Corporation and 68-19 Rego Park LLC ("applicants") with oversight provided by the New York State Department of Environmental Conservation (NYSDEC). The applicants have submitted a proposed Final Engineering Report (FER) for NYSDEC review which states that cleanup requirements have been or will be achieved to fully protect public health and the environment for the proposed site use.

Highlights of the Site Cleanup

The following activities have been or will shortly be completed to achieve the remedial action objectives:

- Excavation Excavation and off-site disposal of about 12,000 cubic yards of contaminated soil and historic fill material exceeding the Residential Use Soil Cleanup objectives, the site-specific cleanup criteria.
- Underground Storage Tanks (USTs) A total of ten USTs, including one 550-gallon UST, four 20-gallon USTs containing waste oil, and five 36-gallon underground hydraulic fluid tanks, were found during the remedial excavations. All USTs were properly removed and disposed of off-site.
- Clean fill Gravel, crushed clean stone and recycled concrete aggregates were brought in to replace the excavated soil and to establish the design grades at the site.
- Vapor Barrier A vapor barrier was installed in the building to protect against soil vapor intrusion.

Next Steps

When NYSDEC approves the FER, it will be made available to the public (see "Where to Find Information"). NYSDEC then will issue a Certificate of Completion (COC) that will be announced in a fact sheet. The applicants would be able to redevelop the site after receiving a COC. In addition, the applicants will be eligible for tax credits to offset a portion of the costs of performing cleanup activities and for redevelopment of the site.

Site Description

The site is located on the corner of Woodhaven Blvd. and 68th Road in the Rego Park neighborhood of Queens. Woodhaven Blvd. is to the west of the site and 68th Road is to the south of the site. A motel and residential housing are located to the north of the site. A residential building and a parking lot are located to the east of the site. The site is identified as Block 3148, Lot 2 on the New York City Tax map. The site's area is 0.588 acres. Past uses of the site included a plant nursery and manufacturing.

Construction for the new development is currently ongoing, and the property was remediated to residential use. The Site will be improved with a six-story mixed-use building.

New York's Brownfield Cleanup Program (BCP) encourages the voluntary cleanup of contaminated properties known as "brownfields" so that they can be reused and redeveloped. These uses may include recreation, housing, business or other uses. A brownfield site is any real property where a contaminant is present at levels exceeding the soil cleanup objectives (SCOs) or other health-based or environmental standards, criteria or guidance adopted by NYSDEC that are applicable based on the reasonably anticipated use of the property, in accordance with applicable regulations.


