Environmental Cleanup to Begin at Brownfield Site

Action is about to begin that will address contamination related to the Beacon Terminal site ("site") located at 555 South Avenue, Beacon, Dutchess County. Please see the map for the site location. The cleanup activities will be performed by 555 South Edgewater, LLC and Beacon Terminal Associates, LP ("applicants") with oversight provided by the New York State Department of Environmental Conservation (NYSDEC). NYSDEC has determined that the Remedial Work Plan (RWP) protects public health and the environment and has approved the plan.

Remedial activities are expected to begin in November 2023 and last about three months.

Highlights of the Upcoming Cleanup Activities: The goal of the cleanup action for the site is to achieve cleanup levels that protect public health and the environment. The key components of the remedy are:

- Excavation and offsite disposal of soil contaminated by toluene and metals exceeding commercial soil cleanup objectives (CSCOs) ranging from 4 feet to 18 feet in depth from the ground surface. Approximately 3740 cubic yards of soil will be excavated and disposed off-site;
- Collection and analysis of post-remedial soil samples to evaluate the effectiveness of the remedy;
- Importing clean soil that meets the established Soil Cleanup Objectives for use as backfill;
- Restoring the site cover (i.e., building slab, asphalt or concrete) where it is compromised, or placement of a 2-foot clean soil cover;
- A site-specific health and safety plan (HASP) and a Community Air Monitoring Plan (CAMP) will be implemented during remediation activities. The HASP and CAMP establish procedures to protect on-site workers and residents and includes required air monitoring as well as dust and odor suppression measures; and
- Recording of the Environmental Easement (EE), which will require development and implementation of the Site Management Plan (SMP) to manage remaining contamination.

Next Steps: After the applicants complete the cleanup activities, they will prepare a Final Engineering Report (FER) and submit it to NYSDEC. The FER will describe the cleanup activities completed and certify cleanup requirements have been achieved or will be achieved.

When NYSDEC is satisfied cleanup requirements have been achieved or will be achieved for the site, it will approve the Final Engineering Report. NYSDEC will then issue a Certificate of Completion to the applicants. The applicants would be able to redevelop the site in conjunction with receiving a Certificate of Completion. In addition, the applicants would be eligible for tax credits to offset the costs of performing cleanup activities and for redevelopment of the site.

NYSDEC will issue a fact sheet that describes the content of the Final Engineering Report. The fact sheet will identify any institutional controls (for example, environmental easements) or engineering controls (for example, a site cover) necessary at the site in relation to the issuance of the Certificate of Completion.

Site Description: The site is located at 555 South Avenue in the City of Beacon, Dutchess County and occupies Section 5954, Block 16, Lot 751258 on Dutchess County tax map. Immediate south of the site is Fishkill Creek, and toward the north of the site is a railroad right of way. To the east and west of the site is Madam Brett Park and an undeveloped/wooded area, respectively. A recreational trail transects through the southern and western portion of the site. The site is 10.5 acres consisting of old vacant industrial buildings, and some wooded areas. The site was used for hat manufacturing, and chemical production and storage until 1995. Since then, the site has been unoccupied.

Site will be cleaned up to allow for restricted residential use with the environmental easement and implementation of site-specific Site Management Plan to manage the remaining contamination below the cover. The site is proposed to be redeveloped by constructing new buildings and renovating some existing building to construct townhouses, duplex and triplex units.


